#### NOTES TO THE INTERIM FINANCIAL REPORT

### A1. Basis of the Preparation

The interim financial report is unaudited and has been prepared in compliance with the requirements of MFRS 134: Interim Financial Reporting and paragraph 9.22 of the Listing Requirements of Bursa Malaysia Securities Berhad.

The interim financial report should be read in conjunction with the audited financial statements of the Group for the year ended 31 December 2014. The major revenue of the Group is contributed by Aturmaju (Sabah) Holding Sdn. Bhd. which is the principal subsidiary of the Company and is principally involved in the operation of an integrated wood processing complex producing veneer and sawn timber.

For the current quarter period, the Group's revenue decreased by 16.66% to RM4.41 million mainly due to lower demand in the market. The Group achieves a loss before taxation result mainly due to higher administration costs incurred in the quarter under review.

Profit before taxation for the quarter under review achieving adverse result as compared to the immediate preceding quarter is due to lower sales generated in the quarter under review.
