NOTES TO THE INTERIM FINANCIAL STATEMENTS FOR QUARTER ENDED 30 JUNE 2011

EXPLANATORY NOTES

1. BASIS OF PREPARATION

On 11 April 2011, the company has acquired 98,000 ordinary shares of Jumbo Universe Sdn Bhd and on the same day, the company has also subscribed for 140,000 new ordinary shares of Jumbo Universe Sdn Bhd. which represents 70% of the total paid up capital of Jumbo Universe Sdn. Bhd.

On 14 April 2011, the company has entered into a Equity Transfer agreement to dispose of its entire 30% interest in its associated company Ire-Tex (Xiamen) Plastics Co. Ltd to Xiamen Hexing Packaging Printing Co. Ltd and HXPP (HK) Co. Ltd for a total consideration of RMB 2,240,000.

On 16 April 2011, the company has disposed of 49% equity interest in each of the two subsidiary companies Eppor-Pack Sdn Bhd and Powertude Sdn Bhd to Renotex Group Ltd for a cash consideration of RM 1,842,533.28 only.

On 27 April 2011, the company has subscribed for USD 80,000 in the registered capital of Ire-Tex (Vietnam) Co., Ltd., which is a wholly owned subsidary.

13. CHANGES IN CONTINGENT LIABILITIES AND CONTINGENT ASSETS

There were no significant changes in contingent liabilities or contingent assets since the last annual financial statements as at 31 December 2010, except for corporate guarantee amounting to RM6,494,624 given to banks for trade facilities and hire purchase facilities granted to subsidiary companies during the quarterly financial statements.

1. REVIEW OF PERFORMANCE

The Group registered a net loss after tax of RM0.387 million for the current quarter as compared to RM1.135 million net profit after tax for the same quarter last year.

The loss was mainly attributed to goodwill written off amounting to RM821,734 as a result of acquisition of subsidiary company (i.e. Jumbo Universe Sdn Bhd), losses incurred from the disposal of associated company (i.e. Ire-Tex Xiamen Plastics Co Ltd) amounting to RM255,661 and losses incurred from shareholding dilution in subsidiaries (i.e. Eppor Pack Sdn Bhd and Powertude Sdn Bhd) during the quarter amounting to RM98,626.

2. COMPARISON WITH PRECEDING QUARTER'S RESULTS

The Group's revenue increased from RM28.057 million in the preceding quarter to RM33.170 million in the current quarter. The revenue for the current quarter increased by 18.22% as compared to preceding quarter mainly due to increase in demands in manufacturing division especially for heavy duty packaging during the quarter.

The Group registered a loss of RM0.387 million for the current quarter as compared to a profit of RM0.860 million in preceding quarter. The loss was mainly due to the reason elaborated in Note 1 above.

3. PROSPECTS OF THE GROUP

In view of fluctuating of crude oil prices that have adversedly affected the cost of petroleum-based raw materials and the increased competition, the Board expects that the prevailing market condition will be demanding and challenging. With the proven improvement from the preceding quarters, the Board will continue to focus on strengthening the Group's financial position and remaining relevant in core manufacturing competency. The Group will continue to implement its strategies of improving and innovating into more cost efficient manufacturing processes, better facilities and material utilization rate and faster production cycles. The Group will also embark on profitable businesses and focus on less price sensitive markets especially for heavy duty packaging industry.

4. PROFIT FORECAST OR PROFIT GUARANTEE

No profit forecast was published for the current quarter and financial year-to-date.
