

NOTES TO THE INTERIM FINANCIAL STATEMENTS FOR THE FIRST QUARTER ENDED 30 NOVEMBER 2013

PART A - EXPLANATORY NOTES IN COMPLIANCE WITH MALAYSIAN FINANCIAL REPORTING STANDARDS ("MFRS") 134, INTERIM FINANCIAL REPORTING

A1. BASIS OF PREPARATION

These condensed interim financial statements, for the period ended 30 November 2013, have been prepared in accordance with MFRS 134 Interim Financial Reporting and paragraph 9.22 of the Listing Requirements of Bursa Malaysia Securities Berhad. These condensed consolidated interim financial statements also comply with IAS 34 Interim Financial Reporting issued by the International Accounting Standards board.

The consolidated financial statements of the Group for the year ended 31 August 2013, which were prepared under MFRS are available upon request from the Company registered office at No. 7 (1st Floor), Jalan Pesta 1/1, Taman Tun Dr Ismail 1, Jalan Bakri, 84000 Muar, Johor Darul Ta'zim.

The explanatory notes attached to these condensed consolidated interim financial statements provide an explanation of events and transactions that are significant to an understanding of the changes in the financial position and performance of the Group since the year ended 31 August 2013.

The interim financial statements should be read in conjunction with the Group's annual audited financial statements for the year ended 31 August 2013.

A2. SIGNIFICANT ACCOUNTING POLICIES

The significant accounting policies adopted are consistent with those of the audited financial statements for the year ended 31 August 2013 and include the adoption of MFRS Framework and Interpretation which applicable to the Group. The adoption of MFRS, amendments to MFRSs and Interpretation Committee Interpretations do not have material impact on the financial statement in the period of initial application.

A3. AUDITORS' REPORT

The audited financial statements for the financial year ended 31 August 2013 was not subject to any qualification.

A4. SEASONAL OR CYCLICAL FACTORS

The Group's operation is seasonal and cyclical in nature whereby the performance for the second quarter (December to February) is normally poorer than the rest of the quarters. This is due mainly to the long festive holidays in Malaysia as well as lower demand for the export markets after Christmas and New Year celebration.

A5. EXTRAORDINARY AND EXCEPTIONAL ITEMS

There were no extraordinary and exceptional items of unusual nature affecting assets, liabilities, equity, net income, or cash flows in the interim financial period ended 30 November 2013.

A6. CHANGES IN ESTIMATES OF AMOUNTS REPORTED

There were no material changes in estimates of amounts reported in prior interim periods or prior financial year that have a material effect in the current financial year to-date.

A7. CHANGES IN DEBT AND EQUITY SECURITIES

There were no issuance, repurchase and repayment of debt and equity securities during the reporting period.

A8. DIVIDENDS PAID

There were no dividends paid during the reporting period.

A9. SEGMENTAL INFORMATION

The Group operates principally within the business of design, manufacture and sale of leather upholstery and wooden furniture products in Malaysia. Accordingly, information by operating segments on the Group's operations as required by MFRS 8 is not presented.

A10. MATERIAL EVENTS SUBSEQUENT TO THE END OF THE INTERIM REPORT

No materials events subsequent to the period ended 30 November 2013 that have not been reflected in the financial statements for the interim period.

There were no changes in the composition of the Group during the financial quarter.

B1. PERFORMANCE REVIEW

The Group's revenue for the first quarter ended 30 November 2013 (Q1 2014) was recorded at RM32.6 mil, 24.4% higher than revenue in the previous corresponding first quarter ended 30 November 2012 (Q1 2013) of RM26.2 mil. The increase of the revenue was mainly due to the increase of demand of leather upholstery sofa and dining sets from overseas whereby the revenue of leather upholstery sofa has increased 41.8% from RM13.4 mil in Q1 2013 to RM19.0 mil in Q1 2014. Meanwhile, the revenue of dining sets has increased 4.9% from RM5.47 mil in Q1 2013 to RM5.74 mil in Q1 2014.

The Group's profit before tax for the Q1 2014 has increased to RM2.085 mil if compared to profit before tax of RM0.68 mil recorded in the Q1 2013. The increase of profit for this quarter was mainly due to the change in business strategy which implemented by the management. By increase the product quality and develop new products, the Group succeed to increase the selling price and retain the customers. The gross margin has increase from 14.6% in Q1 2013 to 18% in Q1 2014.

The Group recorded profit before taxation at RM2.085 mil for the quarter under review compared to RM1.22 mil profit registered in the preceding quarter ended 31 August 2013. The gross margin has increase from 15.9% in Q4 2013 to 18% in Q1 2014. The increase of profit for this quarter was mainly due to the change in business strategy. The management stressed on the capacity of production and it succeed improve the cost efficiency.

B3. PROSPECT FOR THE CURRENT FINANCIAL YEAR

Minimum wage of RM900 for the foreign workers has implemented in small and mediumsized enterprises (SMEs) starts at 01 January 2014. At the same time, the electricity tariff for industrial consumers also increased by an average of about 16.85%.

Given the above scenario, the Group expects challenges ahead with the increases in labour costs and factory overheads. To mitigate these, the Group will strive to further improve efficiency through the higher turnover.

The Group is continuing with the effort to develop new products, new design for existing products, derive better cost efficiencies and effective cost management across all functions. The improvement was attributable to the cost containment measures like reduction in material wastage, lowering the rejection rate and promoting increased efficiency throughout the Group. We continued to stay focus on our strategy of introducing value-based products. Barring unforeseen circumstances, the Board believes that the Group would continue to be profitable in the current financial year ending 31 August 2014.

B4. VARIANCE OF ACTUAL PROFIT FROM FORECAST PROFIT

The Group did not issue any profit forecast or profit guarantee for the year.

The Group's effective tax rate for the quarter under review was lower than the statutory tax rate mainly due to the utilisation of unabsorbed business losses.

In September 2013, its 100% owned subsidiary, Syarikat U.D. Trading Sdn Bhd has entered into a Sale and Purchase Agreements to dispose one plot of land held under Lot 1692 Mukim Pegoh, District of Alor Gajah, State of Melaka with a total carrying value of approximately RM227,000 for a total sale consideration of approximately RM140,000. The estimated completion date will be at February 2014.
