

PART A : EXPLANATORY NOTES AS PER MFRS 134

A1. Basis of Preparation

The interim financial statements are unaudited and have been prepared in compliance with Malaysian Financial Reporting Standards ("MFRS") 134: Interim Financial Reporting, issued by the Malaysian Accounting Standards Board (MASB), International Accounting Standard ("IAS") 34: Interim Financial Reporting, issued by the International Accounting Standard Board ("IASB") and Chapter 9 Part K of the Main Market Listing Requirements of the Bursa Malaysia Securities Berhad ("Bursa Securities").

The interim financial statements should be read in conjunction with the Audited Financial Statements for the year ended 31 December 2012 of Classic Scenic Berhad ("CSCENIC" or "the Company"), which were prepared in accordance with Malaysian Financial Reporting Standards ("MFRSs"). The explanatory notes attached to the interim financial statements provide an explanation of events and transactions that are significant to an understanding of the changes in the financial position and performance of the Group since the financial year ended 31 December 2012.

The auditors' report on the financial statements for the year ended 31 December 2012 of the Group was not qualified.

A3. Seasonal and Cyclical factors

The Group's performance is not subject to seasonality or cyclicality.

There were no unusual items and amounts of items affecting assets, liabilities, equity, net income or cash flows during the current quarter under review and financial year to date.

A5. Material Changes in Estimates

There were no changes in accounting estimates that have had material effect in the current quarter under review and financial year to date.

A6. Issuances and Repayment of Debt and Equity Securities

There were no issuance and repayment of debts and equity securities, shares buy-back, shares cancellation, shares held as treasury shares or resale of treasury shares during the current quarter under review and financial year to date.

A7. Dividends Paid

During the financial year ended 31 December 2013, a second interim dividend comprising franked dividend of 14.4% or 7.2 sen, less 25% tax per ordinary share and tax-exempt dividend of 1.2% or 0.6 sen per ordinary share totalling RM7.2 million in respect of the financial year ended 31 December 2012 was paid on 22 May 2013.

An interim single tier dividend of 8% or 4.0 sen per ordinary share totalling RM4.8 million in respect of the financial year ended 31 December 2013 was paid on 11 November 2013.

B1. Review of Performance

The Group registered a revenue of RM12.4 million for the current quarter, a decrease of RM0.7 million or 5.3% compared to the preceding year corresponding quarter of RM13.1 million mainly due to lower sales revenue from export of wooden picture frame moulding. The Group's profit before tax was RM3.1 million, a decrease of RM0.1 million or 3.1% as compared to RM3.2 million in the preceding year corresponding quarter. The decrease in profit before tax was mainly attributable to lower sales revenue and higher operating expenses. The impact of lower revenue on profit before tax for the current quarter has been mitigated by the strengthening of US Dollar.

For the financial year ended 31 December 2013, the Group's revenue was RM52.4 million, a decrease of RM10 million or 16% compared to the preceding year corresponding period of RM62.3 million mainly due to lower sales revenue from export of wooden picture frame moulding. The Group's profit before tax was RM12.1 million, a decrease of RM5.0 million or 29.2% compared to RM17.1 million in the preceding year corresponding quarter mainly attributable to lower sales revenue and higher raw material costs and labour costs as a result of the implementation of the minimum wage policy in January 2013.

As disclosed in Note A9, the Group is primarily involved in the manufacturing and sale of wooden picture frame moulding and timber products, and its operation are carried out solely in Malaysia. Hence, there is no detailed analysis on revenue and earnings of other business operating segments.

B2. Variation of Results Against Preceding Quarter

The Group recorded similar revenue of RM12.4 million as the preceding quarter. The Group's profit before tax was RM3.1 million, an increase of RM0.6 million or 24.0% compared to RM2.5 million in the preceding quarter mainly attributable to more efficient use of materials and lower operating expenses.

B3. Current Year Prospects

It is still uncertain as to the direction the US economy is heading with certain economic data pointing toward a recovery while others indicate a slowdown. Regardless of the conflicting reports, Federal Reserve is adamant in proceeding with its tapering that could dampen the weak economic recovery. Given all these challanges, we do still firmly believe that our incessant focus on product development to enable us to secure and gain market share would adequately equip us to weather the external challanges and uncertainties. Barring any unforeseen circumstances, we expect to perform satisfactorily for the financial year ending 31 December 2014.

The purpose of entering currency forward contracts is to minimise the impact of unfavourable movement in exchange rate on the trade receivables denominated in United States Dollar. There are no cash requirements for these contracts.

The market risk posed by the Group's currency forward contracts depends on the economic changes that may impact market prices. As the exchange rate is pre-determined under such contracts, the market risk in these instruments is not significant. The currency forward contracts are transacted with the Group's banker and the credit risk for non-performance by the counterparty in these instruments is minimal.

The fair value derivative assets amounting to RM10,000 has been recognised in the financial statements.

B10. Material Litigation

Since the last Audited Financial Statements for the year ended 31 December 2012, the Group does not have any material litigation until the date of this report.

B11. Dividends

The Board had declared a first interim single tier dividend 8% or 4.0 sen per ordinary share totalling RM4.8 million in respect of the financial year ended 31 December 2013, which was paid on 11 November 2013.

The Board is declaring a second interim single tier dividend 8% or 4.0 sen per ordinary share totalling RM4.8million in respect of the financial year ended 31 December 2013. The dividend will be payable on 23 May 2014 to depositors registered in the Record of Depositors on 9 May 2014.

The total net dividend declared for the financial year ended 31 December 2013 was 8.0 sen (2012: 10.5 sen) per ordinary share and the dividend payout ratio was 106% (2012: 95%).
