**18. PROCEDURES FOR APPLICATION AND ACCEPTANCE**

---

**18.1 OPENING AND CLOSING OF APPLICATIONS LISTS**

Applications for the IPO Shares will be accepted from 10.00 a.m. on 31 December 2004 and will be closed at 5.00 p.m. on 7 January 2005 or for such further period or periods as the Directors of CHB, the Offerors and the Underwriter, may in their absolute discretion, mutually decide. **Late applications will not be accepted.**

Any extension to the closing date for the applications will be published in widely circulated English and Bahasa Malaysia newspapers within Malaysia. Accordingly, the balloting, allotment of IPO Shares and listing of CHB may be extended accordingly.

**18.2 METHODS OF APPLICATION**

Applications for the IPO Shares may be made using either of the following ways:

- (i) Application Forms; or
- (ii) Electronic Share Application.

**18.3 PROCEDURES FOR APPLICATION**

Applications shall be made in relation with and subject to the terms of this Prospectus and the Memorandum and Articles of Association of CHB.

**(i) Application by the Bumiputera Investors and Institutions approved by the MITI**

Applications for the 24,000,000 Offer Shares reserved for Bumiputera investors and institutions approved by MITI must be made on the **White** Application Forms provided only and not any other Application Forms or by way of Electronic Share Application. The amount payable in full on application is RM0.75 per Offer Share.

**(ii) Application by the eligible employees and business associates of the CHB Group**

Applications for the 1,500,000 Offer Shares reserved for eligible employees and business associates of the CHB Group must be made only on the **Pink** Application Forms provided and not any other Application Forms or by way of Electronic Share Application. The amount payable in full on application is RM0.75 per Offer Share.

**(iii) Application by the Malaysian public**

Applications for the 3,000,000 Issue Shares and 3,000,000 Offer Shares made available for applications by members of the Malaysian public must be made on the **White** Application Forms provided or by way of Electronic Share Application through a Participating Financial Institution. The amount payable in full on application is RM0.75 per IPO Share.

Persons submitting applications by way of Application Forms may not submit applications by way of Electronic Share Applications and vice versa. A corporation or institution cannot apply for the IPO Shares by way of Electronic Share Application.

**Persons submitting applications by way of Application Forms or by way of Electronic Share Applications MUST have a CDS Account.**

Directors and employees of MIH and their immediate families are strictly prohibited from applying for the IPO Shares in this exercise. The Directors (including one who is designated as a director under the Act) of CHB and its subsidiaries and associates of such Directors are not allowed to apply for the IPO Shares.

**18.4 APPLICATIONS USING APPLICATION FORMS****18.4.1 Application Forms**

The following relevant Applications Forms issued with the notes and instructions printed therein are accompanied by this Prospectus:

- (i) **White** Application Forms for applications by Bumiputera investors and institutions approved by the MITI;
- (ii) **Pink** Application Forms for applications by the eligible employees and business associates of the CHB Group; and
- (iii) **White** Application Forms for applications by Malaysian citizens, companies, societies, co-operatives and institutions, of which at least 30% is to be set aside strictly for Bumiputera individuals, companies, societies, co-operatives and institutions.

**White** Applications Forms together with copies of this Prospectus may be obtained, subject to availability from RHB Sakura, member companies of Bursa Securities, members of the Association of Banks in Malaysia, members of the Association of Merchant Banks in Malaysia and MIH.

**Pink** Application Forms together with copies of this Prospectus will be sent out to eligible employees and business associates of CHB Group.

Only one Application Form from each Applicant will be considered and each application must be for 100 Shares or multiples thereof. **Multiple applications will not be accepted. A person who submits multiple applications in his/her own name or by using the name of others, with or without their consents, commits an offence under Section 87A of the Securities Industry Act, 1983 ("SIA") and if convicted, may be punished with a minimum fine of RM1,000,000 and to a jail term of up to 10 years under Section 88B of the SIA.**

IN THE CASE OF AN INDIVIDUAL APPLICANT OTHER THAN A MEMBER OF THE ARMED FORCES OR POLICE, THE NAME AND NATIONAL REGISTRATION IDENTITY CARD NUMBER OF THE APPLICANT MUST BE EXACTLY THE SAME AS STATED IN THE:

- (i) (a) APPLICANT'S NATIONAL REGISTRATION IDENTITY CARD ("NRIC"); OR
- (b) THE APPLICANT'S "RESIT PENGENALAN SEMENTARA (JPN 1/9)" ISSUED PURSUANT TO PERATURAN 5(5), PERATURAN-PERATURAN PENDAFTARAN NEGARA 1990; OR
- (c) ANY VALID TEMPORARY IDENTITY DOCUMENT AS ISSUED BY THE NATIONAL REGISTRATION DEPARTMENT FROM TIME TO TIME; AND
- (ii) THE RECORDS OF BURSA DEPOSITORY.

WHERE THE APPLICANT IS A MEMBER OF THE ARMED FORCES OR POLICE, THE NAME AND THE ARMED FORCES OR POLICE PERSONNEL NUMBER, AS THE CASE MAY BE, MUST BE EXACTLY THE SAME AS THAT STATED IN AUTHORITY CARD.

IN THE CASE OF A CORPORATE/INSTITUTIONAL APPLICANT, THE NAME AND THE CERTIFICATE OF INCORPORATION NUMBER OF THE APPLICANT MUST BE EXACTLY THE SAME AS THAT STATED IN THE APPLICANT'S CERTIFICATE OF INCORPORATION.

No acknowledgement of the receipt of the Application Forms or application monies will be made by the Company and/or the Issuing House.

**18.4.2 Terms and Conditions for applications using Application Form**

Applications by way of Application Forms shall be made on, and subject to, the terms and conditions set out below:

- (a) Applicant who is an individual must be a Malaysian citizen residing in Malaysia, with Malaysian address and with CDS Account.
- (b) Applicants which are corporations/institutions incorporated in Malaysia must have CDS Accounts and subject to the following:
  - (i) If the corporation/institution has a share capital, more than half of the issued share capital (excluding preference share capital) is held by Malaysian citizens; and
  - (ii) There is a majority of Malaysian citizens on the board of Directors/trustee.
- (c) Applicant which is a superannuation, provident or pension fund must be established or operating in Malaysia and with a CDS Account.
- (d) Applications will not be accepted from trustees, any person under 18 years of age, sole proprietorships, partnership or other incorporated bodies or associations, other than corporations/institutions referred to in Section 18.4.2(b) and (c) of this Section or the trustees thereof.
- (e) Application for the IPO Shares must be made on the Application Form accompanying this Prospectus and must be completed in accordance with the notes and instructions printed on the reverse side of the Application Form and this Prospectus. In accordance with Section 41(2) of the Securities Commission Act, 1993, the Application Form together with the notes and instructions printed therein is accompanied by this Prospectus. Applications which do not **STRICTLY** conform to the terms of this Prospectus or Application Form or notes and instructions printed therein or which are illegible will not be accepted.
- (f) Each completed Application Form must be accompanied by remittance in Ringgit Malaysia for the full amount payable by any of the following:
  - (i) BANKER'S DRAFT or CASHIER'S ORDER purchased within Malaysia only and drawn on a bank in Kuala Lumpur (differentiated by a special red band for Bumiputera applicants); or
  - (ii) CHEQUES issued by participating licensed finance companies in Malaysia and drawn on a bank in Kuala Lumpur (differentiated by a special red band for Bumiputera applicants); or
  - (iii) MONEY ORDER or POSTAL ORDER (for applicants from Sabah and Sarawak only); or
  - (iv) GUARANTEED GIRO ORDER ("GGO") from Bank Simpanan Nasional Malaysia Berhad (differentiated by a special red band for Bumiputera applicants); or

and must be made out in favour of “**MIH SHARE ISSUE ACCOUNT NUMBER 341**” and crossed “**A/C PAYEE ONLY**” (excluding ATM statements) and endorsed on the reverse side with the **NAME AND ADDRESS OF THE APPLICANT**.

Applications accompanied by any mode of payments other than those stated above or with excess or insufficient remittances or inappropriate banker's draft, cashier's order, cheques issued by participating licensed finance companies, GGO, money order, postal order or ATM statement will not be accepted. Details of the remittance must be completed in the appropriate boxes provided in the Application Forms.

- (g) An applicant **MUST** state his/her CDS Account number in the space provided in the Application Forms and he/she shall be deemed to have authorised Bursa Depository to disclose information pertaining to the CDS Account to MIH and/or the Company.
- (h) The name and address of the applicant must be written on the reverse side of the Bankers' Draft, Cashier's Order, ATM Statement, Money Order, Cheques issued by participating licensed finance companies or GGO from Bank Simpanan Nasional Malaysia Berhad.
- (i) The Directors of the Company and the Offerors, reserves the right to require any successful applicant to appear in person at the registered office of MIH at anytime prior to the Listing to ascertain the regularity or propriety of the application. The Directors of the Company and the Offerors shall not be responsible for any loss or non-receipt of the said notice nor shall they be accountable for any expenses incurred or to be incurred by the successful applicant for the purpose of complying with this provision.
- (j) MIH, acting under the authority of the Directors of the Company and the Offerors, reserves the right to reject applications which do not conform to these instructions or which are illegible or which are accompanied by remittances improperly drawn.
- (k) MIH, acting under the authority of the Directors of the Company and the Offerors, reserves the right not to accept any application or accept any application in part only without assigning any reason therefor. Due consideration will be given to the desirability of allotting or allocating the IPO Shares to a reasonable number of applicants with a view to establish an adequate market for the IPO Shares.

- (l) Where an application is not accepted or accepted in part only, the full amount or the balance of the application monies, as the case may be, without interest, will be returned and despatched to the applicant within ten (10) Market Days from the date of the final ballot of the application lists by ordinary post or registered post respectively to the applicant's address last maintained with Bursa Depository, or where the application is not accepted due to the applicant not having provided a CDS Account, to the address per the NRIC or "Resit Pengenaln Sementara (JPN 1/9)" or any valid temporary identity document as issued by the National Registration Department from time to time.
- (m) The applicant shall ensure that his/her personal particulars stated in the Application Forms are identical with the records maintained by Bursa Depository. The applicant must inform Bursa Depository promptly of any change in address failing which the notification letter of successful allocation will be sent to his/her registered or correspondence address last maintained with Bursa Depository.
- (n) MIH, acting under the authority of the Directors of the Company and the Offerors, reserves the right to bank in all application monies from unsuccessful Bumiputera applicants and partially successful Bumiputera applicants, which would subsequently be refunded without interest and shall be despatched to the applicant within ten (10) Market Days from the date of the final ballot of the application lists by registered post to the applicant's address last maintained with Bursa Depository at the applicant's own risk.
- (o) Completed Application Forms accompanied by the appropriate remittance and legible photocopy of the relevant documents must be despatched by **ORDINARY POST** in the official envelopes provided, to the following address:

**18.5 APPLICATION VIA ELECTRONIC SHARE APPLICATIONS****18.5.1 Steps for Electronic Share Application through a Participating Financial Institution's ATM**

- (a) Applicant must have an account with a Participating Financial Institution and an ATM card issued by that Participating Financial Institution to access the account;
- (b) Applicant **MUST** have a CDS Account; and
- (c) Applicant is to apply for the IPO Shares via the ATM of the Participating Financial Institution by choosing the Electronic Share Application option. Mandatory statements required in the application are set out in the terms and conditions for Electronic Share Applications (see Section 18.5.3 below). Applicant is to enter at least the following information through the ATM where the instructions on the ATM screen at which he/she enters his/her Electronic Share Application requires him/her to do so:
  - Personal Identification Number ("PIN");
  - **MIH Share Issue Account Number 341**;
  - CDS Account Number;
  - Number of IPO Shares applied for and/or the RM amount to be debited from the account; and
  - Confirmation of several mandatory statements.

**18.5.3 Terms and Conditions of Electronic Share Applications**

The procedures for Electronic Share Applications at ATMs of Participating Financial Institutions are set out on the ATM screens of the relevant Participating Financial Institutions ("Steps"). For illustration purposes, the procedures for Electronic Share Applications at ATMs are set out in Section 18.5.1 "Steps for Electronic Share Application through a Participating Financial Institution's ATM". The Steps set out the actions that the applicant must take at the ATM to complete an Electronic Share Application. Please read carefully the terms of this Prospectus, the Steps and the terms and conditions for Electronic Share Applications set out below before making an Electronic Share Application. Any reference to the "applicant" in the terms and conditions for Electronic Share Applications and the Steps shall mean the applicant who applies for the IPO Shares through an ATM of any of the Participating Financial Institutions.

Only an applicant who is an individual with a CDS Account is eligible to utilise the facility.

**18. PROCEDURES FOR APPLICATION AND ACCEPTANCE (Cont'd)**

The applicant must have an existing account with, and be an ATM cardholder of, one of the Participating Financial Institutions before he/she can make an Electronic Share Application at an ATM of the Participating Financial Institution. An ATM card issued by one of the Participating Financial Institutions cannot be used to apply for IPO Shares at an ATM belonging to other Participating Financial Institutions. Upon the completion of his/her Electronic Share Application transaction, the applicant will receive a computer-generated transaction slip ("Transaction Record"), confirming the details of his/her Electronic Share Application. The Transaction Record is only a record of the completed transaction at the ATM and not a record of the receipt of the Electronic Share Application or any data relating to such an Electronic Share Application by the Company or MIH. The Transaction Record is for retention by the applicant and should not be submitted with any Application Form.

Upon the closing of the offer for the application for the IPO Shares on 7 January 2005 at 5.00 p.m. ("Closing Date and Time"), the Participating Financial Institution shall submit a magnetic tape containing its respective customers' applications for the IPO Shares to MIH as soon as practicable but not later than 12.00 p.m. of the 2<sup>nd</sup> Market Day after the Closing Date and Time.

An applicant will be allowed to make an Electronic Share Application for IPO Shares *via* an ATM that accepts the ATM cards of the Participating Financial Institution with which he/she has an account and its branches, subject to the applicant making only one application.

AN APPLICANT MUST ENSURE THAT HE/SHE USES HIS/HER OWN CDS ACCOUNT NUMBER WHEN MAKING AN ELECTRONIC SHARE APPLICATION. AN APPLICANT OPERATING A JOINT ACCOUNT WITH ANY PARTICIPATING FINANCIAL INSTITUTION MUST ENSURE THAT HE/SHE ENTERS HIS/HER OWN CDS ACCOUNT NUMBER WHEN USING AN ATM CARD ISSUED TO HIM/HER IN HIS/HER OWN NAME. HIS/HER APPLICATION WILL BE REJECTED IF HE/SHE FAILS TO COMPLY WITH THE FOREGOING CONDITIONS.

The Electronic Share Application shall be made on, and subject to, the above terms and conditions as well as the terms and conditions appearing below:

- i. The Electronic Share Application shall be made in relation with and subject to the terms of this Prospectus and the Memorandum and Articles of Association of the Company.
- ii. The applicant is required to confirm the following statements (by depressing predesignated keys (or buttons) on the ATM keyboard) and undertake that the following information given is true and correct:
  - he/she has attained 18 years of age as at the closing date of the share application;
  - he/she is a Malaysian citizen residing in Malaysia;
  - he/she has read the Prospectus and understood and agreed with the terms and conditions of the application;
  - this is the only application that he/she is submitting; and
  - he/she thereby gives consent to the Participating Financial Institution and Bursa Depository to disclose information pertaining to him/her and his/her account with the Participating Financial Institution and Bursa Depository to MIH and other relevant authorities.

The application will not be successfully completed and cannot be recorded, as a completed transaction at the ATM unless the applicant completes all the steps required by the Participating Financial Institutions. By doing so, the applicant shall be treated as signifying his/her confirmation of each of the above statements as well as giving consent in accordance with the relevant laws of Malaysia including Section 97 of the Banking and Financial Institutions Act, 1989 and Section 45 of the Securities Industry (Central Depositories) Act, 1991 to the disclosure by the relevant Participating Financial Institution or Bursa Depository, as the case may be, of any of the applicant's particulars to MIH, or any relevant regulatory bodies.

- iii. THE APPLICANT CONFIRMS THAT HE/SHE IS NOT APPLYING FOR IPO SHARES AS NOMINEE OF ANY OTHER PERSON AND THAT ANY ELECTRONIC SHARE APPLICATION THAT HE/SHE MAKES IS MADE BY HIM/HER AS BENEFICIAL OWNER. THE APPLICANT SHALL ONLY MAKE ONE (1) ELECTRONIC SHARE APPLICATION AND SHALL NOT MAKE ANY OTHER APPLICATION FOR THE IPO SHARES, WHETHER AT THE ATMs OF ANY PARTICIPATING FINANCIAL INSTITUTION OR ON THE PRESCRIBED APPLICATION FORMS.
- iv. The applicant must have sufficient funds in his/her account with the relevant Participating Financial Institutions at the time he/she makes his/her Electronic Share Application, failing which his/her Electronic Share Application will not be completed. Any Electronic Share Application, which does not strictly conform to the instructions set out on the screens of the ATM through which the Electronic Share Application is being made will be rejected.
- v. The applicant agrees and undertakes to subscribe for or purchase and to accept the number of IPO Shares applied for as stated on the Transaction Record or any lesser number of IPO Shares that may be allotted or allocated to him/her in respect of his/her Electronic Share Application. In the event that the Company decides to allot or allocate any lesser number of such IPO Shares or not to allot or allocate any IPO Shares to the applicant, the applicant agrees to accept any such decision as final. If the applicant's Electronic Share Application is successful, his/her confirmation (by his/her action of pressing the designated key on the ATM) of the number of IPO Shares applied for shall signify, and shall be treated as, his/her acceptance of the number of IPO Shares that may be allotted or allocated to him/her and to be bound by the Memorandum and Articles of Association of the Company.
- vi. MIH, acting under the authority of the Directors of the Company, reserves the right to reject any Electronic Share Application or accept any Electronic Share Application in part only without assigning any reason thereof. Due consideration will be given to the desirability of allotting or allocating the IPO Shares to a reasonable number of applicants with a view to establish an adequate market for the IPO Shares.
- vii. Where an Electronic Share Application is not accepted or accepted in part only, the relevant Participating Financial Institutions will be informed of the non-successful or partially successful applications. Where an Electronic Share Application is not successful, the relevant Participating Financial Institution will credit the full amount of the application monies without interest into the applicant's account with that Participating Financial Institution within two (2) Market Days after the receipt of confirmation from MIH. MIH shall inform the Participating Financial Institutions of the non-successful or partially successful applications within two (2) Market Days after the balloting date. The applicants may check their accounts on the 5<sup>th</sup> Market Day from the balloting day.

Where an Electronic Share Application is accepted in part only, the relevant Participating Financial Institution will credit the balance of the application monies without interest into the applicant's account with the Participating Financial Institution within two (2) Market Days after the receipt of confirmation from MIH. A number of applications will, however, be held in reserve to replace any successfully balloted applications, which are subsequently rejected. For such applications, which are subsequently rejected, the application monies without interest will be refunded to the applicants by MIH by way of cheques issued by MIH. The cheques will be issued to the applicants not later than ten (10) Market Days from the date of the final ballot of the application lists.

Should applicants encounter any problems in their applications, they may refer to the Participating Financial Institutions.

- viii. The applicant requests and authorises the Company:
- (a) to credit the IPO Shares allotted or allocated to the applicant into the CDS Account of the applicant; and
  - (b) to issue share certificate(s) representing such IPO Shares allocated in the name of Bursa Malaysia Depository Nominees Sdn Bhd and sends the same to Bursa Depository.
- ix. The applicant, acknowledging that his/her Electronic Share Application is subject to the risks of electrical, electronic, technical and computer-related faults and breakdowns, fires and other events beyond the control of the Company, MIH or the Participating Financial Institution, irrevocably agrees that if:
- (a) The Company or MIH does not receive the applicant's Electronic Share Application; and
  - (b) Data relating to the applicant's Electronic Share Application is wholly or partially lost, corrupted or not otherwise accessible, or not transmitted or communicated to the Company or MIH,
- the applicant shall be deemed not to have made an Electronic Share Application and the applicant shall not claim whatsoever against the Company, MIH or the Participating Financial Institution for the IPO Shares applied for or for any compensation, loss or damage.
- x. All particulars of the applicant in the records of the relevant Participating Financial Institution at the time he/she makes his/her Electronic Share Application shall be deemed to be true and correct and the Company, MIH and relevant Participating Financial Institution shall be entitled to rely on the accuracy thereof.
- xi. The applicant shall ensure that his/her personal particulars as recorded by both Bursa Depository and the relevant Participating Financial Institutions are correct and identical. The applicant must inform Bursa Depository promptly of any change in address failing which the notification letter of successful allocation will be sent to his/her registered or correspondence address last maintained with Bursa Depository.
- xii. By making and completing an Electronic Share Application, the applicant agrees that:
- (a) in consideration of the Company agreeing to allow and accept the making of any application for the IPO Shares *via* the Electronic Share Application facility established by the Participating Financial Institution at their respective ATMs, his/her Electronic Share Application is irrevocable;
  - (b) the Company, the Participating Financial Institutions, Bursa Depository and MIH shall not be liable for any delays, failures or inaccuracies in the processing of data relating to his/her Electronic Share Application to the Company due to a breakdown or failure of transmission or communication facilities or to any cause beyond their control;
  - (c) notwithstanding the receipt of any payment by or on behalf of the Company, the acceptance of the offer made by the applicant to subscribe for and purchase the IPO Shares for which the applicant's Electronic Share Application has been successfully completed shall be constituted by the issue of notices of successful allocation for prescribed securities, in respect of the said IPO Shares;

- (d) the applicant irrevocably authorises Bursa Depository to complete and sign on his/her behalf as transferee or renounce any instrument of transfer and/or other documents required for the issue or transfer of the IPO Shares allocated to the applicant; and
