The Group recorded a revenue of RM38.28 million for the current quarter under review, an increase of RM0.38 million or 1.00% compared to RM37.90 million recorded in the previous year's corresponding quarter. The slight increase in Group revenue was due to resilience in footfall for the current quarter under review.

The loss before tax for the current quarter was RM13.85 million, an increase of RM11.37 million or 458.47% compared to loss before tax of RM2.48 million recorded in the previous year's corresponding quarter. The higher loss before tax for the current quarter under review was due to an increase in fair value loss on the investment in quoted shares.

The loss before tax was due to an increase in operating expenses and fair value loss on the investment in quoted shares.
