
18. PROCEDURES FOR APPLICATION AND ACCEPTANCE

18.1 OPENING AND CLOSING OF APPLICATIONS

Applications for the Issue Shares will be accepted from 10.00 a.m. on 31 December 2004 and will be closed at 5.00 p.m. on 14 January 2005 or for such further period or periods as the Directors and the Promoters of FMH together with the Underwriter and Placement Agent in their absolute discretion may mutually decide. Late applications will not be accepted. Any extension of the abovementioned dates will be published in widely circulated English and Bahasa Malaysia newspapers within Malaysia.

18.2 METHODS OF APPLICATION

Applications for the Issue Shares may be made using either of the following ways:

- (a) Applications Form; or
- (b) Electronic Share Application.

18.3 PROCEDURES FOR APPLICATION

The applications shall be made in connection with and subject to the terms of this Prospectus and the Memorandum and Articles of Association of the Company.

(i) Application by members of the Malaysian public

Applications for the 6,000,000 Issue Shares made available for applications by Malaysian citizens, companies, co-operatives, societies and institutions, of which at least 30% is to be set aside strictly for Bumiputera individuals, companies, co-operatives, societies and institutions must be made on the **White** Application Forms provided or by way of Electronic Share Application through a Participating Financial Institution. The amount payable in full on application is RM0.65 per Issue Share.

(ii) Application by Bumiputera investors nominated/approved by MITI and identified investors

Applications for the 28,419,000 Issue Shares reserved for Bumiputera investors nominated/approved by MITI and investors identified by the Placement Agent must be made on the **White** Application Forms provided only and **NOT** any other Application Form or by way of Electronic Share Application. The amount payable in full on application is RM0.65 per Issue Share.

(iii) Application by the eligible directors, and employees of FMH and its subsidiary companies

Applications for the 2,800,240 Issue Shares reserved for eligible directors and employees of the FMH and its subsidiary companies must be made on the **Pink** Application Forms provided only and **NOT** any other Application Form or by way of Electronic Share Application. The amount payable in full on application is RM0.65 per Issue Share.

Only one Application Form from each applicant will be considered. **Multiple applications will not be accepted. A person who submits multiple applications using the name of others, with or without their consents, commits an offence under Section 87A of the Securities Industry Act, 1983 and if convicted, may be punished with a minimum fine of RM1,000,000 and to a jail term of up to 10 years under Section 88B of the Securities Industry Act, 1983.** Each application must be for 100 Issue Shares or multiples thereof. Persons submitting applications by way of Application Forms may **not** submit applications by way of Electronic Share Applications and *vice versa*. A corporation or institution cannot apply for the Issue Shares by way of Electronic Share Application.

18. PROCEDURES FOR APPLICATION AND ACCEPTANCE (Cont'd)

PERSONS SUBMITTING APPLICATIONS BY WAY OF APPLICATION FORMS OR BY WAY OF ELECTRONIC SHARE APPLICATIONS MUST HAVE A CDS ACCOUNT.

Applications for the Issue Shares must be made on the respective Application Form issued together with this Prospectus and must be completed in accordance with the Notes and Instructions printed on the reverse side of the Application Form. The Application Form together with the Notes and Instructions printed therein shall constitute an integral part of this Prospectus. Applications which do not **STRICTLY** conform to the terms of this Prospectus or Application Form or Notes and Instructions printed therein or which are illegible will not be accepted.

Directors and employees of MIDFCCS and their immediate family are strictly prohibited from applying for the Issue Shares.

In the case of an individual applicant other than a member of the armed forces or police, the name and national registration identity card number of the applicant must be exactly the same as stated in:

- (i) THE APPLICANT'S NATIONAL REGISTRATION IDENTITY CARD; OR
- (ii) THE APPLICANT'S RESIT PENGENALAN SEMENTARA ("JPN 1/9") issued pursuant to Peraturan 5(5), Peraturan-peraturan Pendaftaran Negara 1990; OR
- (iii) any valid temporary identity document as issued by the National Registration Department from time to time; and
- (iv) the Records of the Depository.

Where the applicant is a member of armed forces or police, the name and the armed forces or police personnel number, (as the case may be) of the applicant must be exactly the same as that stated in his authority card.

In the case of a corporate/institutional applicant, the name and certificate of the incorporation number of the applicant must be exactly the same as that stated in the applicant's certificate of incorporation.

The Company will make no acknowledgement of the receipt of Application Forms or application monies.

18.4 APPLICATION USING THE APPLICATION FORMS
18.4.1 Types of Application Forms

The following Application Forms are issued with the notes and instructions printed therein are accompanied by this Prospectus:

- (a) **White** Application Forms for application by Malaysian citizens, companies, societies, co-operatives and institutions, of which at least 30% is to be set aside strictly for Bumiputera individuals, companies, societies co-operatives and institutions, Bumiputera investors approved/nominated by MITI and investors identified by the Placement Agent; and
- (b) **Pink** Application Forms for applications by the eligible directors and employees of the FMH and its subsidiary companies.

White application Forms together with copies of this Prospectus may be obtained, subject to availability, from RHB Sakura, member companies of the Bursa Securities, members of the Association of Banks in Malaysia, members of Association of Merchant Banks in Malaysia and MIDFCCS.

18. PROCEDURES FOR APPLICATION AND ACCEPTANCE (Cont'd)

18.4.2 Terms and Conditions of Applications Using Application Forms

Application by way of Application Forms shall be made on, and subject to, the terms and conditions below:

- (a) Applicant who is an individual must be a Malaysian citizen residing in Malaysia, with Malaysian address and with CDS Account;
- (b) Applicant which is a corporation/institution incorporated in Malaysia must have a CDS Account and subject to the following:
 - (i) If the corporation/institution has a share capital, more than half of the issued share capital (excluding preference share capital) is held by Malaysian citizens; and
 - (ii) There is a majority of Malaysian citizens on the Board of Directors/trustee.
- (c) Applicant which is a superannuation, provident or pension fund must be established or operating in Malaysia and with a CDS Account
- (d) Applications will not be accepted from trustees, any person under 18 years of age, sole proprietorships, partnership or other incorporated bodies or associations, other than corporations/institutions referred to in Item 18.4.2 (b) and (c) of this Section or the trustees thereof.
- (e) Application for the Issue Shares must be made on the Application Form accompanying this Prospectus and must be completed in accordance with the notes and instructions printed on the reverse side of the Application Form and this Prospectus. In accordance with Section 41(2) of the Securities Commission Act, 1993, the Application Form together with the notes and instructions printed therein is accompanied by this Prospectus. Applications which do not **STRICTLY** conform to the terms of this Prospectus or Application Form or notes and instructions printed therein or which are illegible will not be accepted.
- (f) EACH COMPLETED APPLICATION FORM MUST BE ACCOMPANIED BY REMITTANCES IN RINGGIT MALAYSIA FOR THE FULL AMOUNT PAYABLE EITHER BY:
 - BANKER'S DRAFT OR CASHIER'S ORDER purchased within Malaysia only and drawn on a bank in Kuala Lumpur (differentiated by a special red band for Bumiputera applicants); OR
 - CHEQUES ISSUED BY PARTICIPATING LICENCED FINANCE COMPANIES IN MALAYSIA AND DRAWN ON A BANK IN KUALA LUMPUR (differentiated by a special red band for Bumiputera applicants); OR
 - MONEY ORDER OR POSTAL ORDER (for applicants from Sabah and Sarawak only); OR
 - GUARANTEED GIRO ORDER ("GGO") from Bank Simpanan Nasional (differentiated by a special red band for Bumiputera applicants); OR
 - ATM STATEMENT obtained from any of the following financial institutions:

- (g) An applicant **must** state his/her CDS Account number in the space provided in the application form and he shall be deemed to have authorised the depository to disclose information pertaining to the CDS Account to MIDFCCS or the Company.
- (h) MIDFCCS, acting under the authority of the Directors of FMH, reserves the right to require any successful applicant to appear in person at the registered office of MIDFCCS at anytime prior to the listing of and quotation for the Issue Shares on the Second Board of Bursa Securities to ascertain the regularity or propriety of the Application. The Directors of FMH shall not be responsible for any loss or non-receipt of the said notice nor shall they be accountable for any expenses incurred or to be incurred by the successful applicant to comply with this provision.
- (i) MIDFCCS, acting under the authority of the Directors of FMH, reserves the right to reject Applications which do not conform to these instructions or which are illegible or which are accompanied by remittances improperly drawn.
- (j) MIDFCCS, acting under the authority of the Directors of FMH, reserves the right to reject or accept any application in part only without assigning any reason thereof. Due consideration will be given to the desirability of allotting or allocating the Issue Shares to a reasonable number of applicants with a view to establish an adequate market for the Issue Shares.
- (k) Where an application is rejected or accepted in part only, the full amount or the balance of the application monies, as the case may be, will be refunded without interest and despatched to the applicant within ten Market Days from the date of the final ballot of the application lists by ordinary post or registered post respectively, to the applicant's address registered with the Depository or where the Application is not accepted due to the applicant not having provided a CDS Account to the address as per the national registration identity card or "resit pengenalan sementara (JPN 1/22)" or any valid temporary identity document as issued by the national registration department from time to time or the authority card in the case of armed forces / police personnel at the applicant's own risk.

18.5 APPLICATIONS USING ELECTRONIC SHARE APPLICATION

18.5.1 Steps for Electronic Share Application through a Participating Financial Institution's ATM

- (a) Applicant must have an account with a Participating Financial Institution and an ATM card issued by that Participating Financial Institution to access the account;
- (b) Applicant **MUST** have a CDS Account; and
- (c) Applicant is to apply for the Issue Shares *via* the ATM of the Participating Financial Institution by choosing the Electronic Share Application option. Mandatory statements required in the Application are set out in the terms and conditions for Electronic Share Applications (see Section 18.5.3 below). 18.5.3 Terms and Conditions for Electronic Share Applications

The procedures for Electronic Share Applications at ATMs of the Participating Financial Institutions are set out on the ATM screens of the relevant Participating Financial Institutions ("Steps"). For illustration purposes, the procedures for Electronic Share Applications at ATMs are set out in Section 18.5.1 "Steps for Electronic Share Application through a Participating Financial Institution's ATM". The Steps set out the actions that the applicant must take at the ATM to complete an Electronic Share Application. Please read carefully the terms of this Prospectus, the steps and the terms and conditions for Electronic Share Applications set out below before making an Electronic Share Application. Any reference to the "applicant" in the terms and conditions for Electronic Share Applications and the steps shall mean the applicant who applies for shares through an ATM of any of the Participating Financial Institutions.

Only an applicant who is an individual with a CDS Account is eligible to utilise the facility.

The applicant must have an existing account with, and be an ATM cardholder of, one of the Participating Financial Institutions before he/she can make an Electronic Share Application at an ATM of the Participating Financial Institution. An ATM card issued by one of the Participating Financial Institutions cannot be used to apply for shares at an ATM belonging to other Participating Financial Institutions. Upon the completion of his/her Electronic Share Application transaction, the applicant will receive a computer-generated transaction slip ("Transaction Record"), confirming the details of his Electronic Share Application. The Transaction Record is only a record of the completed transaction at the ATM and not a record of the receipt of the Electronic Share Application or any data relating to such an Electronic Share Application by the Company or MIDFCCS. The Transaction Record is for retention by the applicant and should not be submitted with any Application Form.

Upon the closing of the offer for the Application for the Issue Shares on 14 January 2005 at 5:00 p.m. ("Closing Date and Time"), the Participating Financial Institution shall submit a magnetic tape containing its' respective customers' Applications for the Issue Shares to MIDFCCS as soon as practicable but not later than 12:00 p.m. of the second business day after the Closing Date and Time.

An applicant will be allowed to make an Electronic Share Application for Issue Shares *via* an ATM that accepts the ATM cards of the Participating Financial Institution with which he/she has an account and its branches, subject to the applicant making only one Application.

AN APPLICANT MUST ENSURE THAT HE/SHE USES HIS/HER OWN CDS ACCOUNT NUMBER WHEN MAKING AN ELECTRONIC SHARE APPLICATION. The Electronic Share Application shall be made on, and subject to, the above terms and conditions as well as the terms and conditions appearing below:

18. PROCEDURES FOR APPLICATION AND ACCEPTANCE (Cont'd)

- (a) The Electronic Share Application shall be made in relation with and subject to the terms of this Prospectus and the Memorandum and Articles of Association of MIDFCCS.
- (b) The applicant is required to confirm the following statements (by depressing pre-designated keys (or buttons) on the ATM keyboard) and undertake that the following information given is true and correct:
- He has attained 18 years of age as at the closing date of the Application;
 - He is a Malaysian citizen residing in Malaysia;
 - He has read the Prospectus and understood and agreed with the terms and conditions of the Application;
 - He thereby gives consent to the Participating Financial Institution and the Depository to disclose information pertaining to himself/herself and his/her account with the Participating Financial Institution and the Depository to MIDFCCS and other relevant authorities.

The Application will not be successfully completed and cannot be recorded as a completed transaction at the ATM unless the applicant completes all the steps required by the Participating Financial Institution. By doing so, the applicant shall be treated as signifying his/her confirmation of each of the above statements as well as giving consent in accordance with the relevant laws of Malaysia including Section 97 of the Banking and Financial Institutions Act, 1989 and Section 45 of the Securities Industry (Central Depositories) Act, 1991 to the disclosure by the relevant Participating Financial Institution or the Depository, as the case may be, of any of the applicant's particulars to MIDFCCS or any relevant regulatory bodies.

- (c) THE APPLICANT CONFIRMS THAT HE/SHE IS NOT APPLYING FOR THE ISSUE SHARES AS NOMINEE OF ANY OTHER PERSON AND THAT ANY ELECTRONIC SHARE APPLICATION THAT HE/SHE MAKES IS MADE BY HIM/HER AS BENEFICIAL OWNER. THE APPLICANT SHALL ONLY MAKE ONE ELECTRONIC SHARE APPLICATION AND SHALL NOT MAKE ANY OTHER APPLICATION FOR THE ISSUE SHARES, WHETHER AT THE ATMs OF ANY PARTICIPATING FINANCIAL INSTITUTION OR ON THE PRESCRIBED APPLICATION FORMS.
- (d) The applicant must have sufficient funds in his/her account with the relevant Participating Financial Institution at the time he/she makes his/her Electronic Share Application, failing which his/her Electronic Share Application will not be completed. Any Electronic Share Application which does not strictly conform to the instructions set out on the screens of the ATM through which the Electronic Share Application is being made will be rejected.
- (e) The applicant agrees and undertakes to subscribe for or purchase and to accept the number of Issue Shares applied for as stated on the Transaction Record or any lesser number of Issue Shares that may be allotted or allocated to him/her in respect of his/her Electronic Share Application. In the event that the Company decides to allot or allocate any lesser number of such Issue Shares or not to allot or allocate any Issue Shares to the applicants, the applicant agrees to accept any such decision as final. If the applicant's Electronic Share Application is successful, his/her confirmation (by his/her action of pressing the designated key on the ATM) of the number of Issue Shares applied for shall signify, and shall be treated as, his/her acceptance of the number of Issue Shares that may be allotted or allocated to him/her and to be bound by the Memorandum and Articles of Association of the Company.
- (f) MIDFCCS, acting under the authority of the Directors of FMH, reserves the right to reject any Electronic Share Application or accept any Electronic Share Application in part only without assigning any reason thereof. Due consideration will be given to the desirability of allotting or allocating the Issue Shares to a reasonable number of applicants with a view to establish an adequate market for the Issue Shares.

18. PROCEDURES FOR APPLICATION AND ACCEPTANCE (Cont'd)

- (g) Where an Electronic Share Application is not successful or successful in part only, the relevant Participating Financial Institution will be informed of the non-successful or partially successful applications. Where an Electronic Share Application is not successful, the relevant Participating Financial Institution will credit the full amount of the application monies without interest into the applicant's account with that Participating Financial Institution within two Market Days after the receipt of confirmation from MIDFCCS. MIDFCCS shall inform the Participating Financial Institutions of the non-successful or partially successful applications within two Market Days after the balloting date. The applicants may check their accounts on the fifth Market Day from the balloting date.

Where an Electronic Share Application is successful in part only, the relevant Participating Financial Institution will credit the balance of the application monies without interest into the applicant's account with that Participating Financial Institution within two Market Days after the receipt of confirmation from MIDFCCS. A number of applications will, however, be held in reserve to replace any successfully balloted applications that are subsequently rejected. For such applications that are subsequently rejected, the application monies without interest will be refunded to applicants by MIDFCCS by way of cheques issued by MIDFCCS, not later than ten Market Days from the day of the final ballot of the application lists.

Should applicants encounter any problems in their applications, they may refer to the Participating Financial Institutions.

- (h) The applicant requests and authorises the Company: -
- (i) to credit the Issue Shares allotted or allocated to the applicant into the CDS Account of the applicant; and
 - (ii) to issue share certificate(s) representing such Issue Shares allotted or allocated in the name of Bursa Malaysia Depository Nominees Sdn Bhd and send the same to the Depository.
- (i) The applicant, acknowledging that his/her Electronic Share Application is subject to the risks of electrical, electronic, technical and computer-related faults and breakdowns, fires and other events beyond the control of the Company, MIDFCCS or the Participating Financial Institution, irrevocably agrees that if: -
- (i) The Company or MIDFCCS does not receive the applicant's Electronic Share Application;
 - (ii) Data relating to the applicant's Electronic Share Application is wholly or partially lost, corrupted or not otherwise accessible, or not transmitted or communicated to the Company or MIDFCCS;

the applicant shall be deemed not to have made an Electronic Share Application and the applicant shall not claim whatsoever against the Company, MIDFCCS or the Participating Financial Institutions for the Issue Shares applied for or for any compensation, loss or damage.

- (j) All particulars of the applicant in the records of the relevant Participating Financial Institution at the time he/she makes his/her Electronic Share Application shall be deemed to be true and correct and the Company, MIDFCCS and the relevant Participating Financial Institution shall be entitled to rely on the accuracy thereof.

18. PROCEDURES FOR APPLICATION AND ACCEPTANCE (Cont'd)

- (k) The applicant shall ensure that his/her personal particulars as recorded by both the Depository and the relevant Participating Financial Institution are correct and identical. Otherwise, his/her Electronic Share Application is liable to be rejected. The applicant must inform the Depository promptly of any change in address failing which the notification letter of successful allotment or allocation will be sent to his/her registered address last maintained with the Depository.
- (l) By making and completing an Electronic Share Application, the applicant agrees that:
- (i) in consideration of the Company agreeing to allow and accept the making of any application for the Issue Shares via the Electronic Share Application facility established by the Participating Financial Institution at their respective ATMs, his/her Electronic Share Application is irrevocable;
 - (ii) the Company, the Participating Financial Institutions, the Depository and MIDFCCS shall not be liable for any delays, failures or inaccuracies in the processing of data relating to his Electronic Share Application to the Company due to a breakdown or failure of transmission or communication facilities or to any cause beyond their control;
 - (iii) notwithstanding the receipt of any payment by or on behalf of the Company, the acceptance of the offer made by the applicant to subscribe for and purchase the Issue Shares for which the applicant's Electronic Share Application has been successfully completed shall be constituted by the issue of notices of successful allocation for prescribed securities, in respect of the said Issue Shares;
 - (iv) the applicant irrevocably authorises the Depository to complete and sign on his/her behalf as transferee or renounee any instrument of transfer and/or other documents required for the issue or transfer of the Issue Shares allotted or allocated to the applicant; and
 - (v) the Company agrees that in relation to any legal action or proceedings arising out of or in relation with the contract between the parties and/or the Electronic Share Application Scheme and/or any terms herein, all rights, obligations and liabilities shall be construed and determined in accordance with the laws of Malaysia and with all directives, rules, regulations, and notices from regulatory bodies and that the Company irrevocably submits to the jurisdiction of the Courts of Malaysia.
- (m) MIDFCCS, acting under the authority of the Directors of the Company, reserves the right to require any successful applicant to appear in person at the registered office of MIDFCCS at any time prior to the listing of and quotation for the Issue Shares on the Second Board of Bursa Securities to ascertain the regularity or propriety of the application. The Directors of the Company shall not be responsible for any loss or non-receipt of the said notice nor shall they be accountable for any expenses incurred or to be incurred by the successful applicant to comply with this provision.
- (n) MIDFCCS, acting under the authority of the Directors of the Company, reserves the right to reject applications which do not conform to these instructions.
- (o) A surcharge of RM2.50 per Electronic Share Application will be charged by the respective Participating Financial Institution.

18.6 APPLICATIONS AND ACCEPTANCES

The Directors of FMH reserve the right to reject any application that does not strictly comply with the instructions or to accept any application in part only without assigning any reason thereof.
