The revenue and loss before tax recorded by the Group for the quarter was RM6,496,000 and RM1,271,000 respectively. This represents a decrease of RM54,000 in revenue or 0.8% lower than that of its corresponding quarter. The decrease was mainly due to the following:-

- The Group export sales had decreased by 2.86% and
- Local sales had increased by 2.06%

The Group incurred a loss before tax of RM1,271,000 in the quarter as compared to a loss before tax of RM183,000 in the previous corresponding quarter. The increase loss was primarily due to the following:-

- Lower revenue
- Higher overheads

The Group recorded an decrease in revenue to RM19,211,000 against RM21,308,000 in the previous year mainly due to decrease on export sales. The registered loss before tax of RM3,831,000 against the loss of RM880,000 in the preceding year corresponding period was due to the following:-

- Lower revenue
- Higher overheads

The Group registered a loss before tax for the current quarter ended 30 September2016 of RM1,271,000 as compared to a loss before tax of RM1,396,000 in the previous quarter ended 30 June 2016. The lower loss was mainly attributed by the following:-

- Higher revenue
- Lower operating expenses

B3. Commentary on Prospects

The Group, as reported in the previous quarter, shall continue with its strategy to mitigate the uncertainties of its traditional markets and see through its investments as described in the previous quarters. We envisage it would contribute positively to the performance of the Group in the longer term albeit ongoing project cost and current economic factors will pose a challenge until this financial year end.
