For the quarter

The Group's revenue decreased by 8.3% to RM104.4 million for the quarter under review compared to RM113.9 million for the corresponding quarter last year. The decrease in revenue was due mainly to a lower business volume.

The Group achieved an improvement in profit before taxation of 27.4% for the current quarter under review compared to RM3.5 million achieved for the preceding quarter. The profit before taxation has improved despite the lower revenue due mainly to both an impairment loss on goodwill on acquisition of RM2.7 million and a higher property, plant and equipment written off in the corresponding quarter last year.

However, the Group registered a decrease of 28.4% in profit after taxation to RM3.8 million for the current quarter as compared to the corresponding quarter last year. The decrease is due to a higher provision of income tax after the special export incentive brought forward had been fully utilised and there was an overprovision of deferred tax in the corresponding quarter last year.

For the twelve (12) months period

The Group's revenue decreased by 4.5% to RM462.2 million for the financial year ended 31 July 2017 compared to RM483.8 million for the last financial year. The decrease in revenue was due mainly to lower business volume although average selling prices were higher as a result of the increase in raw material costs.

The Group achieved an improvement in profit before taxation of 27.7% for the financial year ended 31 July 2017 as compared to RM15.4 million achieved for the last financial year. The profit before taxation has improved due mainly to better margins and that in the last financial year, there was an impairment loss on goodwill on acquisition of RM2.7 million as well as property, plant and equipment written off by RM1.3 million.

However, the Group only registered a slight improvement in profit after taxation of RM15.9 million for the financial year ended 31 July 2017 as compared to RM15.4 million achieved for the last financial year. This was mainly due to a higher provision of income tax after the special export incentive brought forward had been fully utilised as well as an overprovision of deferred tax recognised in the last financial year.

The Group's revenue decreased by 12.7% for the quarter under review compared to RM119.5 million registered for the preceding quarter. The decrease in revenue was due mainly to a lower business volume.

The Group registered a decrease in profit before taxation of 11.8% for the current quarter under review compared to RM5.1 million achieved for the preceding quarter due mainly to the lower revenue.

The Group registered a decrease of 2.7% in profit after taxation to RM3.8 million for the current quarter compared to that of the preceding quarter in line with the lower profit before taxation.

B3 Prospects

The global economy continue to strengthen in the second quarter of 2017. Growth was also becoming more synchronised across the advanced and emerging economies. In the US and Euro area, growth drivers were more balanced as the uptrend in investments continued to complement private consumption. These key developments continued to drive global trade. As a result, Asia benefitted from the recovery in global demand amid sustained strength in domestic demand. Nevertheless, the growth outlook remains subject to several risks. These arise mainly from the pace of monetary policy tightening in major economies, protectionist policies, and political uncertainty in parts of Europe. Geopolitical tensions and swings in oil price also pose risks to global growth prospects.

Although the Malaysian economy recorded a stronger growth of 5.8% in the second quarter of 2017 (1Q 2017: 5.6%), the environment continued to remain challenging. The weakened Ringgit Malaysia has resulted in our products being more competitive in the export markets but will escalate the costs of doing business domestically arising from costlier imports. In addition, the recent volatility in aluminium prices has added further uncertainties to our decision-making process. Coupled with the uncertainties in the global economy, the Group expect the forthcoming quarter to be challenging and fraught with uncertainties. In order to maintain its profitability, the Group will focus its efforts to monitor the prices of raw material closely and improving cost efficiencies and recovery to mitigate any adverse impacts on our business.

Barring unforeseen circumstances, the Board is optimistic that the Group will remain profitable for the forthcoming quarter.
