The Group registered a turnover of RM21.75 million during the current quarter ended 31 December 2010 which was 6.9% increase as compared to RM20.35 million achieved in the corresponding quarter of the preceding year. Profit after tax ("PAT") decreased from RM4.26 million to RM3.58 million this quarter. The decrease in PAT was mainly due to the recognition of a non-recurring one-off income of RM1.2 million in the corresponding quarter of the preceding year.

B2 Variance of quarterly results compared to preceding quarter

The Group recorded a lower turnover of RM21.75 million for the current quarter under review compared to the immediate preceding quarter of RM24.31 million.

The profit before tax decreased to RM3.28 million for the current quarter from RM5.66 million registered in the immediate preceding quarter. The decrease was due to lower sales generated in the current quarter compared to the immediate preceding quarter.

B3 Commentary on the prospect

The Group seeks to utilise its expanding production capacity in both Malaysia and China and gain bigger market shares in these markets. The Group will continue to place emphasis to develop the domestic China market. Product research and development activities would be further intensified to develop and launch more innovative products that could cater for different market segments.

On a year-to-date basis, the strengthening of the Malaysia Ringgit/US Dollar exchange rate has negatively impacted the overall performance of the Group as a significant portion of the sales is transacted in US Dollars.

Barring any unforeseen circumstance, the Group is looking forward to maintaining its performance in 2011.
