The paid-up share capital of EIZL is Zambian Kwacha 15,000 (K15,000) divided into 15,000 ordinary shares of K1.00 of which EIL holds 93.33% of ordinary shares with the remaining 6.67% stake to be held by the Zambian business associate. The intended principal activity of EIZL is mining and manufacturing.

On 22 November 2018, the Group announced the receipt of notification on the establishment of a subsidiary company in the Federal Territory of Labuan, Malaysia named Africa Steel Investment Limited ("ASIL") on 21 November 2018. The Company's investment in ASIL is held through EIL. The paid-up share capital of ASIL is USD10 divided into 10 ordinary shares of USD1.00 of which EIL holds 60% of ordinary shares with the remaining 40% stake to be held by a third party investor. The intended principal activity of ASIL is investment holding.

On 03 January 2019, the Group announced the incorporation of a subsidiary known as Shaanxi Longxing Steel Co., Ltd. ("Shaanxi Longxing") in the People's Republic of China. The Company's investment in Shaanxi Longxing is held through its 51% owned subsidiary, ECA. Shaanxi Longxing was incorporated with registered/authorized capital of USD20,000,000 with principal business activities of production, sales, import and export of steel products, machinery and equipment.

The Group's revenue for the fourth quarter ended 31 December 2018 decreased by RM16.6 million from RM42.3 million to RM25.7 million as compared to the preceding year corresponding quarter. The decrease was mainly attributed to the decrease of revenue from machinery and equipment segment during the current quarter.

The Group's loss before tax ("LBT") was RM7.5 million, an increase of RM6.8 million as compared to LBT of RM0.7 million recorded in preceding year corresponding quarter. The performance of each business segment for the fourth quarter as compared to the preceding year corresponding quarter is presented as follows:-

(a) Machinery and equipment segment

This segment recorded revenue of RM3.8 million for the current quarter as compared to RM16.0 million achieved in the previous year corresponding quarter, representing an decrease of RM12.2 million equivalent to 76.3%. LBT was RM3.0 million, a drop of RM7.2 million equivalent to 1.71 times as compared to PBT of RM4.2 million achieved during the corresponding quarter in preceding year. The decrease is mainly due to lower revenue generated and impact from the adoption of MFRS 9: Financial Instruments.

(b) Steel product and trading activity segment

The revenue for the current quarter was RM21.8 million, representing a decrease of RM4.4 million from RM26.2 million reported in the preceding year corresponding quarter. LBT was registered at RM3.6 million, a 20% increase compared to LBT of RM3.0 million recorded in the previous year corresponding quarter. The higher LBT is due to the lower revenue generated, higher production cost and higher operating expenses for the promotion of "Constructor" brand racking systems.

(c) Property, investment holding and other segment

This segment represents trading of non-steel products, other manufacturing and services income derived from the Group's properties offset against operating expenses from all other segments. This segment recorded LBT of RM0.8 million, a decrease of RM1.0 million or 55.6% as compared to LBT of RM1.8 million in the corresponding quarter in preceding year. The LBT is mainly due to the losses in biocoal project.

The Group recorded a current quarter LBT of RM7.5 million, representing a decrease of RM13.5 million from PBT of RM6.0 million in the preceding quarter mainly due to lower revenue generated from the machinery and equipment segment, lower revenue and higher production cost incurred for steel product and trading activity segment, as well as impact from adoption of MFRS 9 and impairment losses on inventory.
