# Amendments as to the consequence of effective of MFRS 17 Insurance Contracts

The Group and the Company plan to adopt the above applicable new MFRS and amendments/improvements to MFRSs when they become effective. A brief discussion on the above significant new MFRS and amendments/improvements to MFRSs that may be applicable to the Group and the Company are summarised below.

#### Annual Improvements to MFRS Standards 2018–2020

Annual Improvements to MFRS Standards 2018-2020 covers amendments to:

• MFRS 1 First-time Adoption of Malaysian Financial Reporting Standards – simplifies the application of MFRS 1 by a subsidiary that becomes a first-time adopter after its parent in relation to the measurement of cumulative translation differences.

• MFRS 9 Financial Instruments – clarifies the fees an entity includes when assessing whether the terms of a new or modified financial liability are substantially different from the terms of the original financial liability.

• Illustrative Examples accompanying MFRS 16 Leases – deletes from Illustrative Example 13 the reimbursement relating to leasehold improvements in order to remove any potential confusion regarding the treatment of lease incentives.

• MFRS 141 Agriculture – removes a requirement to exclude cash flows from taxation when measuring fair value thereby aligning the fair value measurement requirements in MFRS 141 with those in other MFRS Standards.

#### Amendments to MFRS 3 Business Combinations

The amendments update MFRS 3 by replacing a reference to an old version of the Conceptual Framework for Financial Reporting with a reference to the latest version which was issued by Malaysian Accounting Standards Board in April 2018.

## Amendments to MFRS 101 Presentation of Financial Statements

The amendments include specifying that an entity's right to defer settlement of a liability for at least twelve months after the reporting period must have substance and must exist at the end of the reporting period; clarifying that classification of liability is unaffected by the likelihood of the entity to exercise its right to defer settlement of the liability for at least twelve months after the reporting period; clarifying how lending conditions affect classification of a liability; and clarifying requirements for classifying liabilities an entity will or may settle by issuing its own equity instruments.

## Amendments to MFRS 101 Presentation of Financial Statements (Cont'd)

The amendments require an entity to disclose its material accounting policy information rather than significant accounting policies. The amendments, amongst others, also include examples of circumstances in which an entity is likely to consider an accounting policy information to be material to its financial statements. To support this amendments, MFRS Practice Statement 2 was also amended to provide guidance on how to apply the concept of materiality to accounting policy information disclosures. The guidance and examples provided in the MFRS Practice Statement 2 highlight the need to focus on entity-specific information and demonstrate how the four-step materiality process can address standardised (or boilerplate) information and duplication of requirements of MFRSs in the accounting policy information disclosures.

### Amendments to MFRS 108 Accounting Policies, Changes in Accounting Estimates and Errors

The amendments revise the definition of accounting estimates to clarify how an entity should distinguish changes in accounting policies from changes in accounting estimates. The distinction is important because the changes in accounting estimates are applied prospectively to transactions, other events, or conditions from the date of that change, but changes in accounting policies are generally also applied retrospectively to past transactions and other past events.

## Amendments to MFRS 112 Income Taxes

The amendments specify how an entity should account for deferred tax on transactions such as leases and decommissioning obligation.

In specified circumstances, MFRS 112 exempts an entity from recognising deferred tax when it recognises assets or liabilities for the first time. There had been some uncertainties about whether the exemption from recognising deferred tax applied to transactions such as leases and decommissioning obligations – transactions for which an entity recognises both an asset and a liability. The amendments clarify that the exemption does not apply and that entity is required to recognise deferred tax on such transactions.

### Amendments to MFRS 116 Property, Plant and Equipment

The amendments prohibit an entity from deducting from the cost of property, plant and equipment amounts received from selling items produced while the entity is preparing the asset for its intended use. Instead, an entity shall recognise such sales proceeds and related cost in profit or loss.

## Amendments to MFRS 137 Provisions, Contingent Liabilities and Contingent Assets

The amendments specify which costs an entity includes in determining the cost of fulfilling a contract for the purpose of assessing whether the contract is onerous.

For the current quarter under review, the Group recorded sales revenue of RM7.3 million and LBT of RM1.91 million as compared with the sales revenue of RM10.2 million and LBT of RM0.42 million in the corresponding quarter of the preceding financial period.

The overall losses were impacted by the increase in labour cost as a result of manpower shortage and increase of minimum wages in Malaysia, supply chain discruption and increase in raw material cost.

#### Segmental review for current quarter and financial year to date:

The performance of the business segments for the current quarter ended 30 June 2022 as compared to preceding quarter ended 30 June 2021 is as below:

#### a) Manufacturing

During the current quarter, lower sales were reported impacting the profitability as overheads remained high. The Group is now adopting a more prudent approach in managing sales and credit to its customers in order to mitigate credit risk at the expense of lower sales. The Ukraine war, which started in early 2022, will further exacerbate supply shortages leading to inflation and a possibility of global recession.

## b) Product distribution

Online sales has seen continued demand especially for the Group's healthcare products under the JADICARE private label, which also contributed to improve visibility and awareness of its range of printing supplies, premium stationeries and 3D printers.

#### b) Investment Holding

Increase in administrative cost was impacted by a one time cost due to the proposal of private placement.

The performance of the geographical segments for the current quarter 30 June 2022 as compared to preceding quarter 30 June 2021 is as below:

a) Malaysia

The overall losses were impacted by high shipping costs, coupled with inflation and the weakened ringgit have severely impacted the GP marign.

b) China

China's manufacturing activities is slowing down due to the COVID-19 pandemic lockdown, while international market has just started the recovery, this has caused the decrease in the demand of compatible cartridges.

The Group expects toner demand among catridge makers in China to remain modest against the backdrop of a highly uncertain global business environment as caused by the COVID-19 pandemic coupled with the continuing shift in business model among some industry players outside China from one of catridge remanufacturing to another involving primarily sales and distribution of Chinese-made compatible catridges. Moving forward, the Group will carry on to develop its market share particularly in the high value product segment by capitalising on its technological know-how as well as expanded production capacity in Chemical Produced Toner ("CPT") while continuing to explore and establish stronger partnership with new and existing distributors/dealers.

The Group will strive to expand the sales of its e-commerce business by introducing more specially curated high-quality products with the objective of enhancing the quality of life for all consumers.
