#### **B1.** Review of Performance

The Group achieved revenue of RM26.6 million for the quarter ended 30 September 2007. This represents an increase of approximately 7% compared to the corresponding quarter in the preceding year. Despite the increase in the revenue, profit before taxation of the Group registered a drop of 49% compared to the corresponding quarter in 2006 mainly due to lower gross profit margin, higher preliminary loss incurred by the Vietnam subsidiary and higher overall operating costs. The gross profit margin dropped mainly due to the weaker United States Dollar.

## B2. Comment on Material Changes in the Profit Before Taxation for the Quarter Reported on as Compared With Immediate Preceding Quarter

The Group achieved revenue of approximately RM26.6 million for the current quarter under review as compared to RM24.9 million in the previous quarter, registering a increase of approximately 7%. The increase was mainly attributable to the increase in the overall sales.

Profit before taxation of the Group for the current quarter under review decreased from RM2.1 million in the previous quarter to RM1.1 million for the current quarter. The contributing factors to the lower profit before tax for the current quarter are reported in Note B1.

#### **B3.** Current Year Prospects

The Board expects the performance for remaining quarter to be challenging, and the overall performance for the year would be lower compared to the preceding year.
