#### T7 GLOBAL POSTS 42.1% GROWTH IN PATAMI FOR 9MFYE2024

- Q3FYE2024 revenue, PBT and PATAMI increased by 28.4%, 17.5% and 42.1% respectively
- 9MFYE2024 revenue and PBT grew by 36.8% and 28.6% respectively
- Industrial solution segment's revenue grew by 108.4% in 9MFYE2024

Kuala Lumpur, 27 November 2024 – Energy solutions provider, T7 Global Berhad ("T7 Global" or the "Group", Bursa: 7228, Bloomberg: T7G:MK, Reuters: TGLO.KL) (T7 全球集团) today announced its third quarter results for the financial year ending 31 December 2024 ("Q3FYE2024").

For the quarter under review, T7 Global delivered a robust financial performance with revenue of RM176.4 million, profit before tax ("PBT") of RM17.4 million, and profit after tax and minority interest ("PATAMI") of RM11.4 million, representing a year-on-year (Y-o-Y) growth of 28.4%, 17.5% and 42.1% respectively.

For the cumulative 9 months ("9MFYE2024"), the Group achieved cumulative revenue of RM458.9 million and PBT of RM41.1 million, reflecting growth of 36.8% and 28.6% respectively. The Group's PATAMI was RM26.6 million, marking a 42.1% Y-o-Y growth. The strong results were primarily driven by industrial solutions division 108.4% revenue growth.
