B1. Review of performance

The Group achieved revenue of RM106.04 million for the financial year ended 31 Mar 2024 with corresponding profit before tax of RM8.27 million and profit after taxation of RM6.05 million. For financial year ended 31 Mar 2023, the Group recorded revenue of RM89.98 million with corresponding profit before taxation of RM1.46 million and profit after taxation of RM1.00 million. Revenue improved by approximately 17.85% mostly due to increase in demand with corresponding improvement in margin attributed to higher productivity and efficiency.

B2. Variation of results against preceding quarter

The Group recorded slight increase of revenue by approximately 2.05% with RM26.92 million for the current quarter under review as compared to RM26.38 million in the previous quarter. The Group recorded higher profit before taxation of RM2.79 million and profit after taxation of RM1.87 million for current financial period under review as compared to profit before taxation of RM1.32 million and profit after taxation of RM1.18 million for preceding quarter, due to lower operating cost during the quarter under review.

B3. Current year prospects

The Group will continue to improve the performance of all the segments by improving the demand for its products thus achieving better economies of scales whilst continue implementing measures to reduce expenditure. However, the Group takes cautious approach in view of the weakening local currency as well as continuous rising costs.

Barring any unforeseen circumstances, the Board expects the Group to continue to achieve satisfactory performance.
