FRS139: Financial Instruments: Recognition and Measurement

FRS 139 establishes principles for recognizing and measuring financial assets and financial liabilities. The Group has adopted FRS 139 prospectively on 1 April 2010. In accordance with the transitional provisions, the effect arising from the adoption of this Standard has been accounted for by adjusting the opening balances of retained earnings as at 1 April 2010. Comparatives are not restated. The details of the changes in accounting policies and the effects arising from the adoption of FRS139 are as below:-

i) Financial assets

The Group classifies its financial assets into the following specified categories: financial assets 'at fair value through profit or loss, 'held-to-maturity' investments, 'available-forsale' financial assets and 'loans and receivables'. The classification depends on the nature and purpose of the financial assets and is determined at the time of initial recognition.

Non current receivables and other receivables

Non current receivables and other receivables were previously recognized at their cost and subsequently stated at cost less allowance for doubtful debts. With the adoption of FRS 139, an impairment loss is recognized and is measured as the difference between the asset's carrying amount and the present value of estimated future cash flows discounted using the effective interest method.

ii) Financial liabilities

Financial liabilities are classified as fair value through profit or loss and as amortized using the effective interest method.

The Group classified trade and other payables, customer deposits and borrowings as other financial liabilities, These recognized initially at fair value and subsequently measured at amortized cost using the effective interest method.

In accordance with the transitional provisions of FRS 139, the above changes are applied prospectively and the comparative figures of the Group as at 31 March 2010 are not restated. Instead , the changes have been accounted for by restating the following balance in the statement of financial position as at 1 April 2010.

PART B - EXPLANATORY NOTES PURSUANT TO APPENDIX 9B OF THE MAIN MARKET LISTING REQUIREMENTS OF BURSA MALAYSIA SECURITIES BERHAD

B1. PERFORMANCE REVIEW

The Group recorded a profit before tax of RM7.72 million for the current period under review as compared to a loss before tax of RM0.14million for the preceding year's corresponding quarter.

For the year ended 31 March 2011, the group recorded a profit before tax of RM11.31million as compared to RM4.18million for the year ended 31 March 2010. Engineering Division recorded a higher contribution in operating profit due to over provisions of project costs in prior years.

B2. COMMENT ON MATERIAL CHANGES IN PROFIT BEFORE TAXATION

The Group recorded a profit before taxation of RM7.72million for the current quarter, as compared to the loss before taxation of RM0.18million for the preceding quarter. The significant increase in results was mainly attributable from engineering division and share of profit from an associate company.

The Group's prospects for the coming financial year are expected to be influenced by the competitive construction and trading conditions.

Barring unforeseen circumstances, the group anticipate continued growth in retailing division.
