SUPERLON DELIVERS STRONG RESULTS FOR Q1FY2017

1st Quarter (Q1FY2017) vs Corresponding Quarter (Q1FY2016)

- Revenue of RM25.6 million, up 16% from RM22.1 million
- Net profit of RM6.0 million, up 57% from RM3.9 million

Klang, Malaysia, 27 September 2016 – Malaysia’s leading rubber insulation manufacturer, Superlon Holdings Berhad (**SuperIn**, 世霸龍, 世霸龙; Bloomberg: SLON:MK; Reuters: SPLH.KL) today announced its financial results for the first quarter of the financial year ending 30 April 2017 (“Q1FY2017”). The Company’s consolidated net profit jumped 57% to RM6.0 million whilst revenue improved by 16% to RM25.6 million against the corresponding period in the previous financial year (“Q1FY2016”).

Revenue from the Manufacturing and Trading divisions grew by 14% to RM23.9 million and 52% to RM1.7 million respectively compared to Q1FY2016. Revenue growth in the Manufacturing division was led by higher demand of thermal insulation products from both export and local markets. The Trading division reported higher revenue mainly due to increased demand for copper pipes.

The topline growth was supported by increase in sales volume coupled with favourable exchange rates.

Jessica Liu, Managing Director of Superlon, commented, “We recorded encouraging results and volume growth in the first quarter amidst the current challenging as well as unpredictable economic climate.”
