GLOSSARY OF TECHNICAL TERMS

- Branded Kitchen Systems** : Kitchen Systems that have brand names, which are used to distinctly differentiate one supplier from another. Branded Kitchen Systems are commonly sold as predesigned and complete set with some options in finishing, materials and accessories. Customers do not have the options of totally redesigning a Branded Kitchen Systems. Operators are commonly companies with retail showrooms.
- Built-In Kitchen Appliances** : The appliances that are specifically built into the Kitchen Systems such as built-in microwave ovens, extractor hoods, cooking hobs and ovens
- Interior Fit-Out** : The design, planning and installation of furnishing and fixtures of the interior of buildings or homes. Interior Fit-Out can be for refurbishment of existing buildings and homes or fit-out of new buildings and homes.
- Kitchen Systems** : The complete furniture, fittings, accessories and appliances commonly found in a kitchen. A Kitchen System essentially includes cabinets, storage areas and countertops as the basic components and may include kitchen islands and other fittings, accessories and appliances such as kitchen sinks, cooking hobs, ovens, extractor hoods, dishwashing machines and refrigerators.
- MDF** : Medium density fibreboard
- Non-Branded Kitchen Systems** : Kitchen systems that do not have brand names. They may be predesigned or customers have the option of totally designing the Kitchen Systems from scratch. Operators in this category are commonly individuals such as carpenters, sub-contractors, sole proprietors and tradesperson, all of whom may also work in conjunction with renovation and interior fit-out contractors. Operators do not normally have retail showrooms.
- Wardrobe Systems** : A system of storage areas for clothing, footwear, accessories and household linen. It is an integrated storage system comprising shelving, hanging areas, drawers, shoe racks and other specialised storage compartments. Wardrobe Systems may be walk-in or reach-in.
- White Goods** : The large and major household appliances including refrigerators, washing machines, dishwashers, dryers, air conditioners and others
