Α. NOTES TO THE QUARTERLY FINANCIAL REPORT

1 **Basis of preparation**

The interim financial statements are unaudited and have been prepared in accordance with paragraph 9.22 of the Listing Requirements of the Bursa Malaysia Securities Berhad, and Financial Reporting Standard (FRS) 134: Interim Financial Reporting, issued by the Malaysian Accounting Standards Board (MASB).

For the 3 months period ended 31 March 2009, the Group achieved a turnover of RM36,574,000 compared to RM39,668,000 of the same period last year, decreased by RM3,094,000 or 7.80%, mainly due to the weaker sales volume for the 3 months period ended 31 March 2009.

The Group recorded a profit before taxation of RM4,071,000 against the profit before taxation of RM580,000 in the previous corresponding period, mainly due to the lower cost of goods manufactured for the 3 months period ended 31 March 2009.

2 Variation of results against preceding quarter

The Group reported a profit before taxation of RM4,071,000 for the first quarter ended 31 March 2009 compared to a profit before taxation of RM1,921,000 in the preceding quarter mainly due to the lower cost of goods manufactured for the first quarter ended 31 March 2009.

3 Current year prospects

The directors expect the performance of the Group will be more challenging for the financial year ending 31 December 2009 in view of the recent H1N1 virus and the slowdown in global economy.

4 Profit forecast

No profit forecast was provided for the current quarter and financial year-to-date.
