If you have not registered such bank account with Bursa Depository the refund will be made by issuance of cheque and shall be despatched to you by ordinary post to the address shown in the record of depositors at your own risk within fifteen (15) market days from the last date for application of and payment for the excess Rights Shares with Warrants.

It is the intention of our Board to allot the excess Rights Shares with Warrants applied for under Part I(B) of the RSF, if any, on a fair and equitable basis in the following priority:-

- (i) firstly, to minimise the incidence of odd lots;
