NOTES TO INTERIM FINANCIAL STATEMENTS

1. Basis of preparation

The interim financial statements are unaudited and have been prepared in accordance with the requirements of FRS 134 - Interim Financial Reporting and paragraph 9.22 of the Listing Requirements of Bursa Malaysia Securities Berhad.

The interim financial statements should be read in conjunction with the audited financial statements of the Group for the year ended 31 January 2013. These explanatory notes attached to the interim financial statements provide an explanation of events and transactions that are significant to an understanding of the changes in the financial position and performance of the Group since the year ended 31 January 2013.

2. Accounting policies

The accounting policies and methods of computation adopted consistent with those adopted in the financial statements for the year ended 31 January 2013 except for the adoption of the following new Financial Reporting Standards ("FRSs"), Amendments and Issues Committee ("IC") Interpretations with effect from 1 January 2012.

The directors expect that the adoption of the standards and interpretations above will have no material impact on the financial statements in the period of initial application, except as disclosed below:

(a) Amendments to FRS 101: Presentation of Items of Other Comprehensive Income

The amendments to FRS 101 change the grouping of items presented in Other Comprehensive Income. Items that could be reclassified (or "recycled") to profit or loss at a future point in time (for example, upon derecognition or settlement) would be presented separately from items that will never be reclassified. The amendment affects presentation only and has no impact on the Group's financial position or performance.

(b) FRS 9: Financial Instruments

FRS 9 reflects the first phase of work on the replacement of FRS 139 and applies to classification and measurement of financial assets and financial liabilities as defined in FRS 139. The adoption of this first phase of FRS 9 will have an effect on the classification and measurement of the Group's financial assets but will potentially have no impact on classification and measurements of financial liabilities.

(c) FRS 10: Consolidated financial statements

FRS 10 replaces the portion of FRS 127 Consolidated and Separate Financial Statements that addresses the accounting for consolidated financial statements. FRS 10 establishes a single control model that applies to all entities including special purpose entities. The changes introduced by FRS 10 will require management to exercise significant judgement to determine which entities are controlled, and therefore, are required to be consolidated by a parent, compared with the requirements that were in FRS 127.

Accounting policies (continued)

(d) FRS 13: Fair Value Measurement

FRS 13 establishes a single source of guidance under FRS for all fair value measurements. FRS 13 does not change when an entity is required to use fair value, but rather provides guidance on how to measure fair value under FRS when fair value is required or permitted.

Malaysian Financial Reporting Standards (MFRS Framework).

On 19 November 2011, the Malaysian Accounting Standards Board (MASB) issued a new MASB approved accounting framework, the Malaysian Financial Reporting Standards (MFRS Framework).

The MFRS Framework is to be applied by all Entities Other Than Private Entities for annual periods beginning on or after 1 January 2012, with the exception of entities that are within the scope of MFRS 141 Agriculture (MFRS 141) and IC Interpretation 15 Agreements for Construction of Real Estate (IC 15), including its parent, significant investor and venturer (herein called 'Transitioning Entities').

Transitioning Entities will be allowed to defer adoption of the new MFRS Framework for an additional one year. Consequently, adoption of the MFRS Framework by Transitioning Entities will be mandatory for annual periods beginning on or after 1 January 2014.

The Group falls within the scope definition of Transitioning Entities and accordingly, will be required to prepare financial statements using the MFRS Framework in its first MFRS financial statements for the year ending 31 January 2015. In presenting its first MFRS financial statements, the Group will be required to restate the comparative financial statements to amounts reflecting the application of MFRS Framework. The majority of the adjustments required on transition will be made, retrospectively, against opening retained earnings.

Accordingly, the consolidated financial performance and financial position as disclosed in these financial statements for the year ended 31 January 2013 could be different if prepared under the MFRS Framework.

3. Audit report

There was no audit qualification in the audit report of the preceding annual financial statements.

4. Seasonal and cyclical factors

The Group's operations are affected by seasonal crop production, weather conditions and fluctuating commodity prices.

5. Unusual items due to their nature, size of incidence

There were no items affecting the assets, liabilities, net income or cash flows that are unusual because of their nature, size or incidence for the interim period.

6. Changes in estimates

There were no significant changes in the amount of estimates that have had a material effect in the current financial results.

7. Debt and equities securities

There were no issuances, cancellations, repurchases, resale and repayments of debt and equities securities for the current financial period under review.

8. Dividend paid

There was no dividend payment during the current financial period-to-date.

Palm Oil Products

The palm oil products segment remained the Group's main source of revenue, which contributed 95.4% of the revenue of the Group in the current quarter.

Fresh fruit bunches yield recorded a decrease of approximately 10.2% as compared with preceding year corresponding quarter. Sales volume for crude palm kernel oil and palm kernel expeller had also registered a decrease by 28.6% and 99.2% respectively.

For the quarter under review, revenue for this segment increased slightly from RM 37.3 million in preceding year corresponding quarter to RM 38.7 million in current quarter. The increase was mainly attributed to increase in revenue from trading of palm oil products.

The palm oil products segment turned in an operating profit of RM3.2 million in the current quarter compared to a loss of RM1.0 million in the preceding year corresponding quarter. The increase was mainly attributed to improved dynamics in the operating environment in the current quarter.

Cocoa Products

Cocoa products segment contributed 4.6% of the revenue of the Group. Revenue for this segment decreased from RM2.8 million in preceding year corresponding quarter to RM 1.8 million in current quarter, a decrease of 35.7%. The decrease in revenue was mainly attributed to a decrease in trading volume in the current quarter.

Segmental operating loss has increased from RM201,000 in the preceding year corresponding quarter to RM816,000 in current quarter. The increase in loss was mainly attributed to a decrease in selling price for cocoa products in the current quarter.

10. Valuations of property, plant and equipment

The valuations of property, plant and equipment have been brought forward without amendment from the previous financial statements.

11. Changes in composition of the Group

There are no changes in the composition of the Company and the Group for the financial quarter ended 31 July 2013.

12. Discontinued operation

There was no discontinued operation during the quarter ended 31 July 2013.

13. Capital commitment

There were no material capital commitments as at the end of the quarter under review.

14. Contingent liabilities

There were no material contingent liabilities since the last annual balance sheet date.

16. Subsequent Events

There were no material events subsequent to the end of the year that have not been reflected in the financial statements for the period.

17. Review of Group's Performance

For the quarter under review, revenue for the Group increased slightly from RM40.1 million to RM40.6 million as compared with preceding year corresponding quarter. The increase was mainly attributed to the increase in export volume from trading of palm oil products.

18. Comment On Material Changes In Profit Before Taxation

The Group registered a profit before taxation of RM1.4 million as compared with a profit of RM2.3 million in the immediate preceding quarter. The decrease was mainly attributed to a decrease in operating margin for palm oil products in the current quarter.

19. Current Year Prospects

Barring unforeseen circumstances, fresh fruit bunches yield for the current financial year is expected to improve with more palms attaining prime age and the adoption of comprehensive fertilizing program; however, the direction of market price for fresh fruit bunches remains uncertain.

The recent improvement in crude palm kernel oil price is expected to maintain for the rest of the financial year due to increase in global demand.

The market for the cocoa products segment, although its contribution on group basis is small, still remains uncertain.

For the remaining period of this financial year, the management remains cautiously positive in the operation of the Group.

20. Profit Forecast

The Group did not announce any profit forecast or profit guarantee during the current financial period.
