The parties are desirous of co-operating and jointly participate in the bidding of Request For Proposal (RFP) for Large Scale Solar Photovoltaic Edition 3 (LSS3) as announced by the Ministry of Energy, Science, Technology, Environment and Climate Change (MESTECC). Ajiya Bhd's subsidiary, ASG Marketing Sdn Bhd (ASGM) is a third party in a court case involving a contractor and the building owner. ASGM's lawyer advised that the probability of ASGM's success in the case is reasonable. The cost related to the replacement of the products is approximately RM2.5million, if ASGM is liable.
