# Part A - Explanatory Notes Pursuant to MFRS 134

The value was determined based on market comparable approach and adopting recent transactions as a yardstick and sale evidences involving other similar properties in the vicinity.

For the period under review the Group achieved a revenue of RM92.839 million, which was 23.0% higher compared to preceding year's corresponding period of RM75.503 million. The increase in revenue during the current period was mainly due to improvement in market demand for the Group's products.

The profit before tax for the current period of RM18.013 million was 87.4% higher compared to preceding year corresponding period profit before tax of RM9.613 million. The profit before tax for the current period was mainly contributed from realized gain on disposal of other investments and properties.
