#### **Explanatory Notes**

#### Explanatory notes pursuant to MFRS 134, "Interim Financial Reporting"

#### 1. Basis of Preparation

The unaudited interim financial statements is prepared in accordance with Malaysian Financial Reporting Standards ("MFRS") 134, "Interim Financial Reporting" issued by Malaysian Accounting Standards Board ("MASB") and paragraph 9.22 of the Listing Requirements of Bursa Malaysia Securities Berhad and should be read in conjunction with the Group's audited financial statements for the financial year ended 31 March 2018.

The accounting policies, method of computation and basis of consolidation applied in the unaudited interim financial statements are consistent with those used in the preparation of the last annual audited financial statements, for the financial year ended 31 March 2018 except for the changes arising from the adoption of the following amendments to MFRS issued by MASB that are effective for the Group's financial year beginning on 1 April 2018.

Adoption of new and amended standards

- Amendments to MFRS 107 Disclosure Initiative
- Amendments to MFRS 112 Recognition of Deferred Tax Assets for Unrealised Losses
- Annual Improvements to MFRSs 2014 2016 Cycle Amendments to MFRS 12

The adoption of the Amendments to MFRS 107 has required additional disclosure of changes in liabilities arising from financing activities. Other than that, the adoption of above amendments to MFRSs did not have any significant impact on the financial statements of the Group.

## 2. Audit qualification in respect of the audit report of the Group and Company for the preceding financial statements and current status of the matter(s) giving rise to the qualification

The auditors have expressed unqualified opinion of the financial statement for the financial year ended 31 March 2018. However the auditors draw attention to the material uncertainty related to going concern due to the Group's net current liabilities which arises from reclassification on Islamic Medium Term Notes ("IMTN") to current liabilities as a result of noncompliance with financial covenants as required in IMTN.

Subsequent to the financial period, the company had raised RM40,713,330 mainly to settle the IMTN of RM40,000,000 which is due on 18 March 2019. Upon the settlement of this IMTN of RM40,000,000, the Company is working to restructure the final balance of RM50,000,000 which will be due next year."

#### 3. Explanatory comments about the seasonality or cyclicality of interim operations

The Group's products cater to the consumer market and business is influenced by the state of the Malaysian economy, consumer confidence and the seasonality of promotional sales and festive seasons.

### 4. The nature and amount of items affecting assets, liabilities, equity, net income, or cash flow that are unusual because of their nature, size or incidence

Save for the information disclosed in this interim financial report, there are no other unusual items affecting assets, liabilities, equity, net income or cash flow.

#### The nature and amount of material changes in estimates of amounts reported in prior interim periods of the current financial year or material changes in estimates of amounts reported in prior financial year

There was no material changes in estimates of amounts reported in prior financial year.

#### 6. Issuances, cancellations, repurchases, resale and repayments of debt and equity securities

Subsequent the financial period, the company has issued 116,323,800 ordinary shares for RM0.35 per share raising RM40,713,330.

#### 7. The amount of dividends paid (aggregate or per share)

There were no dividends paid by the Company during the quarter ended 31 December 2018.

#### 8. Segmental reporting for business segment, being the Group's basis of segment reporting

Segmental reporting is not presented as we are operating in a single business segment.

#### 9. Status of valuation of property, plant and equipment

There was no valuation of property, plant and equipment carried out during the current financial quarter.

## 10. Material events subsequent to the end of the interim period that have not been reflected in the financial statements for the interim period

There are no material events subsequent to the end of the interim period that have not been reflected in the financial statements for the current interim period.

# 11. Effect of changes in the composition of the Group during the interim period, including business combinations, acquisition or disposal of subsidiary companies and long-term investments, restructurings, and discontinuing operations

There were no changes to the composition of the Group during the financial period ended 31 December 2018.

#### 12. Changes in contingent liabilities or contingent assets since the last annual balance sheet date

The Company's contingent liabilities in respect of corporate guarantees granted to subsidiaries for banking and financing facilities as at 31 December 2018 amounted to RM106,000,000 (31 March 2018: RM108,000,000).

# 13. Review of performance of the Company and principal subsidiaries, setting-out material factors affecting earnings and/or revenue of the Company and Group for the financial year-to-date

The current quarter revenue period ended 31 December 2018 amounted to RM41.8 million, which was RM6.3 million or 17.7% higher than RM35.5 million for the same quarter last year. The Group recorded a pre-tax profit of RM1.9 million as compared to a pre-tax loss of RM4.1 million for the same period of the preceding year. The higher revenue and pre-tax profit were due to the better stores productivity over the period.

Revenue for the 9 months period ended 31 December 2018 amounted to RM117.0 million, which was RM2.2 million or 1.9% higher than RM114.8 million for the corresponding 9 months period last year. For the current 9 months period, the Group recorded pre-tax profit amounting to RM5.1 million as compared to a pre-tax loss of RM3.5 million for the corresponding 9 months period last year. This is due to the same reason as above.

#### 14. Comparison with preceding quarter's results

The Group recorded an increase in revenue of RM6.3 million for the current quarter ended 31 December 2018 to RM41.8 million as compared to RM35.5 million in the preceding quarter ended 30 September 2018.

The Group recorded a pre-tax profit of RM1.9 million for the current quarter ended 31 December 2018 as compared to pre-tax profit of RM1.3 million recorded for the quarter ended 30 September 2018. This is mainly due to the current quarter being a festive quarter.

#### 15. Current year prospects

Action plans to close down non-performing outlets and replacing them with new and cost efficient retail formats in improving profitability and margins is on-going. With a stronger balance sheet the group looks forward to capture market opportunities and increase its market share this financial year.

We are hopeful that the overall economic outlook would continue to improve and consumer spending would follow.

#### 16. Status of profit forecast or profit guarantee

This is not applicable to the Group.
