In making this judgment, the Directors have concluded that all leasehold land are finance leases because the present value of the minimum lease payments (i.e. the consideration paid or payable) is substantially equal to the fair value of the land. Accordingly, the Group has changed the classification of leasehold lands from operating leases to finance leases in the current quarter. This change in classification has no effect to the profit or loss of the current period ended 31 December 2010 or the comparative prior period. Stronger sales reported by the business forms and data print services and commercial printing segments were offset by weaker sales reported by the flexible packaging segment. For the 9 months ended 31 December 2010 revenue for the Group was higher by 1.4% as compared with the corresponding 9 months in the preceding year. This slight increase was primarily due to the stronger sales reported by the commercial printing segment.

The Group reported a profit before tax of RM2.9 million for the current quarter which was 5.7% lower than the corresponding period in the preceding year. This was due to weaker results reported by the flexible packaging segment which was adversely affected by higher raw material costs. For the 9 months ended 30 December 2010 profit before tax for the Group was RM4.9 million which was higher by 13% as compared with the corresponding 9 months in the preceding year. This increase was primarily due stronger results reported by the business forms and data print services and commercial printing segments.
