13. Review of Financial Performance

The revenue of the Group for the current quarter remained fairly stable at RM16.875 million against RM16.605 million in the previous year corresponding quarter.

The profit before tax increased by 11.5% to RM0.601 million from RM0.539 million in the previous year corresponding quarter, mainly due lower raw latex cost.

14. Variation of Results Against Preceding Quarter

The revenue for current quarter increased by 8.7% to RM16.875 million against preceding quarter's RM15.531 million. Profit before tax increased by 2.4% to RM0.601 million from RM0.587 million in preceding quarter. The current quarter is affected by the implementation of minimum wages as well as the electricity tariff hike which came into effect in Jan 2014.

15. Prospect for the Current Financial Year

In view of the current uncertainties in the world economy, the Board expects challenging times ahead in the coming months. The changes in any of the

- iii) Changes in tariff including electricity and natural gas.
