13. Review of Financial Performance

The revenue of the Group for the current quarter increased by 28.2% to RM17.790 million against RM13.880 million in the previous year corresponding quarter. The increase was mainly due to lackluster performance in Q2 2013 caused by poor market sentiment.

The profit before tax increased by 275% to RM0.532 million from RM0.193 million in the previous year corresponding quarter, mainly due to improved sales in the current quarter.

14. Variation of Results Against Preceding Quarter

The revenue for current quarter increased by 5.4% to RM17.790 million against preceding quarter's RM16.875 million. Profit before tax was lower at RM0.532 million against RM0.601 million in preceding quarter. The current quarter was affected by the hike in gas prices as well as adverse forex changes.

15. Prospects for the Current Financial Year

In view of the current uncertainties in the world economy, the Board expects
