13. Review of Financial Performance

The revenue of the Group for the current quarter decreased by 17.8% to RM14.6 million against RM17.8 million in the previous year corresponding quarter. The decrease was mainly due to poor domestic sales after the implementation of the Goods and Services Tax (GST) on 1st April 2015.

The profit before tax decreased by 19.2% to RM0.43 million from RM0.53 million in the previous year corresponding quarter, mainly due to the decrease in sales in the current quarter.

14. Variation of Results Against Preceding Quarter

The revenue for current quarter decreased by 35.4% to RM14.6 million against preceding quarter's RM22.6 million, mainly due to higher reported domestic sales prior to the implementation of the Goods and Services Tax (GST) in the preceding quarter, and poor domestic sales after GST came into effect in current quarter. As a result of the decrease in sales, profit before tax decreased by 70% to RM0.43 million from RM1.43 mil in preceding quarter.

15. Prospects for the Current Financial Year

In view of the current uncertainties in the world economy, the Board expects challenging times ahead in the coming months. The changes in any of the following factors may have a direct impact on the performance of the Group in 2015:

- i) Fluctuation in the raw latex price.
- ii) The changes in exchange rate especially the US Dollar which remains the main foreign currency for our export business.
- iii) Consumer sentiment and confidence level in spending with the implementation of Goods and Services Tax GST from 1st April 2015.
- iv) The health of the property sector which will have direct impact on furnishing requirements.
