### PART A - EXPLANATORY NOTES PERSUANT TO MASB 26

### 1. Basis of Preparation and Significant Accounting Policies

The interim financial report is unaudited and has been prepared in accordance with MASB 26 - Interim Financial Reporting and Chapter 9 Part K of the Listing Requirements of Bursa Malaysia Securities Berhad ("Bursa Malaysia"), and should be read in conjunction with the audited financial statements of the Company for the financial year ended 31 December 2003.

The same accounting policies and methods of computation are adopted in the interim financial statements as those used in the preparation of the most recent annual financial statements for the year ended 31 December 2003.

# PART B - EXPLANATORY NOTES PERSUANT TO CHAPTER 9 PART K OF THE LISTING REQUIREMENTS OF BURSA MALAYSIA

#### 15. Performance Review

Turnover for the quarter under review was RM18.9 million as against RM16.2 million of the previous corresponding period, representing an increase of RM2.7 million or 16.7%. The Company registered a pretax loss of RM33,000 during the quarter as against a pre-tax loss of RM429,000 in the corresponding period. The reduced loss was mainly due to increase in the sales volume in current quarter as against the previous corresponding period.

### 16. Material Changes in Quarterly Results compared to the Results of the Immediate Preceding Quarter

The turnover for the quarter under review was higher at RM18.9 million as against RM16.4 million in the last quarter, representing a increase of RM2.5 million or 15.2%. The Company registered a pre-tax loss of RM33,000 for the quarter under review as compared to a pre-tax loss of RM481,000 (after adjusted for inventory) in the previous quarter. The reduction in pre-tax loss was mainly due to increase of sales volume in current quarter. Additionally, provisions were made for retirement gratuity in the previous quarter.

### 17. Current Year Prospects

As the overall plastic packaging industry is experiencing sharp price increases in major petroleum-based raw materials in tandem with the soaring oil prices, the Directors are of the opinion that the overall performance of the Company for the current financial year will be extremely competitive and at least be maintained as in previous year.

### 18. Profit Forecast or Profit Guarantee

Not applicable for the quarter under review.

### 19. Taxation

There is no provision for taxation in the current quarter and current financial period to-date as the Company have sufficient unabsorbed capital allowances brought forward to set off its tax liabilities.

### 20. Profits/(loss) on Sale of Unquoted Investments and/or Properties

There were no sale of unquoted investments and/or properties for the current quarter and financial year-to-date.

## 21. Quoted Securities

There is no quoted securities nor were there any purchases or disposals of quoted securities for the current quarter and financial year-to-date.

The basic earnings per share for 2003 is calculated by dividing the net loss for the period under review by the weighted average number of ordinary shares in issue of 35,212,037 during the financial year, adjusted retrospectively as a result of the rights and bonus issues completed in October 2003.
