## 14. Performance Review

Turnover for the quarter under review was RM17.6 million as against RM18.9 million of the previous corresponding quarter, representing a decrease of RM1.3 million or 7\%. The Company registered a pre-tax loss of RM553,000 during the quarter as against a pre-tax loss of RM33,000 in the corresponding quarter. The lower than expected seasonal demand of certain major product line adversely affected the turnover as well as profitability during the reporting quarter. The higher stock write-off in the current quarter compared to the previous corresponding quarter also affected profitability.
15. Material Changes in Quarterly Results compared to the Results of the Immediate Preceding Quarter The turnover for the quarter under review was slightly lower at RM17.6 million as against RM18.7 million in the last quarter, representing a decrease of RM1.1 million or $6 \%$. The Company registered a pre-tax loss of RM553,000 for the quarter under review as compared to a pre-tax loss of RM81,000 in the previous quarter. The impact of recent high crude oil price which surpassed the USD70/barrel was particularly felt in the quarter under review. The Company's performance was grossly affected by the drop in margin as a result of increase in prices of petroleum-based raw materials in general and decrease in sales volume as well as higher stock written off.
16. Current Year Prospects

The high crude oil price is expected to have a dampening effect on consumption and demand. The Company does not expect its performance for the current year to improve from previous under the adverse conditions prevailing in the market.

Not applicable for the quarter under review.

## 18. Taxation

There is no provision for taxation in the current quarter and current financial year as the Company have sufficient unabsorbed capital allowances brought forward to set off against its tax liabilities.
