#### NOTES TO THE INTERIM FINANCIAL REPORT FOR THE FINANCIAL QUARTER ENDED 30 APRIL 2023

#### PART A: EXPLANATORY NOTES PURSUANT TO MFRS 134

#### A1 Basis of preparation

The interim financial report is unaudited and has been prepared in accordance with MFRS 134 Interim Financial Reporting and paragraph 9.22 and Appendix 9B of Bursa Malaysia Securities Berhad Main Market Listing Requirements.

The interim financial statements should be read in conjunction with the audited financial statements of the Group for the financial year ended 31 July 2022 which were prepared under Malaysian Financial Reporting Standards ("MFRS"). These explanatory notes attached to the interim financial statements provide an explanation of events and transactions that are significant to an understanding of the changes in the financial position and performance of the Group since the financial year ended 31 July 2022.

The accounting policies adopted in the preparation of the interim financial statements are consistent with those adopted for the annual audited financial statements for the financial year ended 31 July 2022, except for the adoption of the following amendments to MFRSs that are effective for the financial statements effective from 1 August 2022, as disclosed below:

#### Current quarter review

For the current financial quarter ended 30 April 2023, the Group achieved revenue of RM177.49 million, reflecting a reduction of 14.4% compared to RM207.43 million recorded in the preceding year corresponding quarter. The decline in revenue was mainly due to lower demand from both domestic and export markets with the domestic market contributing RM96.41 million or 54.3% of group revenue and exports contributing RM81.08 million or 45.7% of group revenue.

Despite the lower revenue, operating profit rose by 15.1% to RM14.15 million from RM12.29 million in the preceding year corresponding quarter. The improvement in operating profit was mainly attributable to softening of raw material prices, favourable product mix and gradual normalisation of freight costs, which was offset by increases in electricity costs and other operating expenses.

#### 9-month review

For the 9-month financial period ended 30 April 2023, the Group revenue increased marginally by 1.2% to RM589.47 million, compared to RM582.21 million recorded in the preceding year corresponding period. Domestic sales contributed RM308.16 million or 52.3% of the group revenue whilst exports contributed the balance RM281.31 million or 47.7% of the group revenue.

On the other hand, operating profit rose 42.1% to RM48.40 million from RM34.05 million recorded in the preceding year corresponding period. The growth in operating profit was mainly attributed to the reasons as stated in the current quarter review.

For the three months ended 30 April 2023, group revenue decreased 10.4% to RM177.49 million from RM198.06 million in the preceding quarter mainly due to lower demand from both domestic and export markets.

Group PBT stood at RM12.83 million compared to RM15.42 million posted in the preceding quarter. The reduction in PBT was due to the decline in revenue and rising energy costs.

#### B3 Current financial year prospects

The volatility in the financial and economic environment, the ongoing geopolitical uncertainties coupled with rising inflationary pressures continue to weigh in and dampen consumer consumption, translating into reduced demand and rising operational costs.

Amidst a challenging external operating environment, the Group continues to invest for longer term growth and innovations to develop customer centric products that meet customers product sustainability and performance requirements. Our capacity expansion plan which is intended to enhance production capacity and capabilities remains on track, placing us in a good position to capitalise on growth opportunities. The Group is also progressively embedding sustainable practices and processes in its manufacturing process as part of its objective to promote sustainably manufactured products to further boost the circular economy. Our focus on technology and innovations has seen the Group commercialising flexible plastic packaging solutions which are fully recyclable, value added and providing the required functional performance and this has further reinforced our position in the market.

The socioeconomic conditions in Myanmar continues to pose operational challenges in the foreseeable short and medium term. The Group will nonetheless continue to manage its operations to minimise adverse effects whilst exploring options pertaining to its Myanmar operations.

Barring any unforeseen circumstances, the Group remains optimistic that it will be able to sustain its performance for the financial year.
