NOTES TO THE INTERIM FINANCIAL REPORT FOR THE FINANCIAL QUARTER ENDED 30 APRIL 2024

PART A: EXPLANATORY NOTES PURSUANT TO MFRS 134

A1 Basis of preparation

The interim financial report is unaudited and has been prepared in accordance with MFRS 134 Interim Financial Reporting and paragraph 9.22 and Appendix 9B of Bursa Malaysia Securities Berhad Main Market Listing Requirements.

The interim financial statements should be read in conjunction with the audited financial statements of the Group for the financial year ended 31 July 2023 which were prepared under Malaysian Financial Reporting Standards ("MFRS"). Current quarter review

For the current financial quarter ended 30 April 2024, the Group achieved revenue of RM182.85 million, reflecting an increase of 3.0% compared to RM177.49 million recorded in the preceding year corresponding quarter. The increase was mainly due to higher sales in its export market. Export sales contributed RM90.09 million or 49.3% of the group revenue whilst domestic market contributed the balance RM92.76 million or 50.7% of the group revenue.

For the current financial quarter under review, operating profit increased to RM14.27 million from RM14.15 million in the preceding year corresponding quarter. The marginal improvement in operating profit was consistent with the increase in revenue.

9-month review

For the 9-month financial period ended 30 April 2024, the Group recorded revenue of RM531.67 million, a decrease of 9.8% compared to RM589.47 million recorded in the preceding year corresponding period, mainly due to lower demand from both its export and domestic markets. Exports as a percentage to group revenue reduced to 44.4% compared to 47.7% in the preceding year corresponding period.

Operating profit decreased 23.1% to RM37.23 million from RM48.40 million recorded in the preceding year corresponding period. The reduction in operating profit was mainly attributed to the decline in revenue and product mix.

For the three months ended 30 April 2024, the Group revenue increased 4.0% to RM182.85 million from RM175.85 million in the preceding quarter. PBT also recorded higher at RM13.49 million, an increase of 26.9% compared to preceding quarter of RM10.63 million mainly due to product mix and improvement in operational efficiency.

B3 Current financial year prospects

The global market outlook remains challenging due to the ongoing political uncertainties, rising inflationary pressures as well as soft market sentiments.

Amidst the challenging backdrop, the Group is committed to maintain its operational efficiencies and competitiveness, through initiatives such as optimisation of machine utilisation, wastage control and increase workforce productivity. With the sufficed operational capacity and capability, the Group strives to focus on innovation and developing customer centric packaging products so to meet the increasing portfolio of fully recyclable packaging solutions as well as applications which embedded sustainability into our operation processes and outputs.

As part of its effort towards sustainable energy consumption, the Group is also in the midst of implementing the solar rooftop photovoltaic (PV) system. The installation is scheduled to commence in the second half of the year and is expected to be completed by January 2025. With this commitment to renewable energy, the Group will be able to reduce its environmental footprint in our value chain, further aligning to the sustainability goals of its customers both locally and internationally.

The Group foresees that the socioeconomic conditions in Myanmar will continue to remain challenging with no sign of abatement. The Group will observe the conditions and national policy changes within the locality to minimise adverse effects towards its operation whilst exploring options pertaining to its Myanmar operations.

The Group is committed to enhance its competitiveness and capitalise on new growth opportunities and to deliver a sustainable performance in the current financial year.
