NOTES TO THE INTERIM FINANCIAL REPORT FOR THE FINANCIAL QUARTER ENDED 31 OCTOBER 2024

PART A: EXPLANATORY NOTES PURSUANT TO MFRS 134

A1 Basis of preparation

The interim financial report is unaudited and has been prepared in accordance with MFRS 134 Interim Financial Reporting and paragraph 9.22 and Appendix 9B of Bursa Malaysia Securities Berhad Main Market Listing Requirements.

The interim financial statements should be read in conjunction with the audited financial statements of the Group for the financial year ended 31 July 2024 which were prepared under Malaysian Financial Reporting Standards ("MFRS"). Current quarter review

For the current financial quarter ended 31 October 2024, the Group achieved revenue of RM179.29 million, reflecting an increase of 3.6% compared to RM172.97 million recorded in the preceding year corresponding quarter. The increase was mainly due to higher sales in its export market. Export sales contributed RM86.80 million or 48.4% of the group revenue whilst domestic market contributed the balance RM92.49 million or 51.6% of the group revenue.

Despite the higher revenue, the Group's operating profit dipped 51.1% to RM5.67 million from RM11.60 million in the preceding year corresponding quarter. The decline in operating profit was primarily due to changes in sales mix and fluctuations in foreign exchange rates.

For the three months ended 31 October 2024, the Group achieved revenue of RM179.29 million, a slight decrease of 1.4% compared to RM181.84 million recorded in the preceding quarter.

A lower PBT of RM4.67 million was recorded, reflecting a 52.3% decline compared to RM9.80 million recorded in the preceding quarter. PBT margins in the current quarter were impacted by changes in sales mix and higher foreign exchange losses.

B3 Current financial year prospects

The global market outlook remains challenging, shaped by ongoing political uncertainties, inflationary pressures, and subdued market sentiment.

The Group remains steadfast in managing operational costs and maintaining competitiveness through optimised machine utilisation, waste reduction and enhance workforce productivity.

With sustainability becoming a key priority in consumers' modern lifestyle, the Group leverages its technical expertise and innovation capabilities to deliver customer-centric packaging solutions that meet the evolving market demand while supporting our sustainability goal.

As part of its sustainability effort to reduce carbon footprint in operation, the Group is progressing with the installation of solar rooftop photovoltaic (PV) system. The Group is on track to complete the installation of solar rooftop PV system by January 2025. This initiative will contribute to energy cost reduction and lower Scope 2 emissions, reinforcing our commitment to integrating renewable energy into our operations and to create shared value for its customers both locally and internationally.

The socioeconomic conditions in Myanmar remain challenging due to ongoing political instability. The Group continues to monitor the situation and national policy changes to minimise any adverse impact on operations, while exploring alternative options for its Myanmar operations.

The Group is committed to enhancing its competitiveness and driving sustainable performance in the current financial year.
