#### Part A - Explanatory Notes Pursuant To Malaysian Financial Reporting Standard 134

#### 1. Basis of Preparation

The interim financial report is unaudited and have been prepared in compliance with Malaysian Financial Reporting Standard (MFRS) 134 - Interim Financial Reporting, issued by the Malaysian Accounting Standards Board ("MASB") and Part A of Appendix 9B of the Listing Requirements of Bursa Malaysia Securities Berhad ("BMSB").

The same accounting policies and methods of computation are followed in the quarterly financial statements as compared with the annual financial statements of the Group for the year ended 31 December 2012.

Apart from the above, the quarterly financial statements are to be read in conjunction with the Annual Financial Statements for the year ended 31 December 2012.

#### 2. Financial Reporting Standards

Significant accounting policies adopted by the Group in these interim financial statements are consistent with those of the audited financial statements for the year ended 31 December 2012.

The Group has adopted the Malaysian Financial Reporting Standards ("MFRS") framework issued by MASB with effect from 1 January 2012. This MFRS framework was introduced by MASB in order to fully converge Malaysia's existing Financial Reporting Standards ("FRS") framework with the International Financial Reporting Standards ("IFRS") framework issued by the International Accounting Standards Board. There has been no material impact upon the adoption of the MFRS on the financial statements of the Group.

The Group has also adopted all the relevant new and revised MFRSs and IC Interpretations that are relevant and effective for accounting periods beginning on or after 1 January 2013. The adoption of these new and revised MFRS and IC Interpretations have not resulted in any material impact upon the financial statements of the Group.

MFRSs and IC Interpretations that were issued but are not yet effective have not been early adopted by the Group.

#### 3. Auditors' Report on Preceding Annual Financial Statements

There was no qualification of the Group audited financial statements for the year ended 31 December 2012.

The total gross dividend paid for the financial year todate is 8% per share.

# Part B - Explanatory Notes Pursuant To Appendix 9B Of The Listing Requirements Of Bursa Malaysia Securities Berhad

#### 15. Review Of Performance

Group revenue decreased by RM0.59 million (-4.72%) to RM12.0 million during the current quarter as compared to RM12.59 million achieved in the corresponding quarter in 2012, while Group pretax profit increased by RM0.18 million (+9.47%) to RM2.10 million as compared to RM1.92 million achieved in the corresponding quarter of 2012.

The decrease in revenue in the current quarter was mainly attributable to the slower economic growth in Malaysia as compared to the corresponding quarter in 2012. Pretax profit in the current quarter was higher because in the corresponding quarter in 2012, there were impairment losses on capital work-in-progress and slow-moving stocks.

For the current year to-date, Group revenue decreased by RM0.79 million (-2.13%) to RM36.21million while Group pretax profit decreased marginally by RM0.06 million (-0.95%) to RM6.56 million as compared to the corresponding period in 2012. The decrease in pretax profit was mainly attributable to the increase in the cost of petroleum-based raw materials and higher operating costs.

For the current quarter, revenue decreased by 3.66% to RM12.00 million while pretax profit decreased by 9.23% to RM2.10 million as compared to the previous quarter's revenue of RM12.45 million and pretax profit of RM2.32 million respectively. The decrease in revenue during the current quarter was due to slower local sales (-RM0.46 million) which also contributed to the reduction in the pretax profit.

#### 17. Prospects For 2013

The global economic condition continued to be very mixed, with the United States of America showing signs of recovery while the Euro zone region and the Asian economies are reporting slower growth. In spite of the economic slowdown, the Asean, as well as the Malaysian automobile industry, are still enjoying relatively healthy growth in motor vehicles sales which will continue to support the auto refinish industry and this trend is beneficial to the Group's principal activities.

While the Group's revenue may be underpinned by the increasing motor vehicles population, Group's profitability may be marginally affected by the rising cost of petroleum-based raw materials and the weakening of the Ringgit. However, barring any unforeseen circumstances, the Board is optimistic that the Group will remain profitable in the last quarter of 2013.
