A EXPLANTORY NOTES IN COMPLIANCE WITH MALAYSIAN FINANCIAL REPORTING STANDARDS ("MFRS") 134, INTERIM FINANCIAL REPORTING

A1 Basis of Preparation

The interim financial statement is unaudited and have been prepared in compliance with Malaysian Financial Reporting Standards ("MFRSs") 134, Interim Financial Reporting, issued by the Malaysian Accounting Standards Board ("MASB") and paragraph 9.22 and Appendix 9B of the Main Market Listing Requirements of Bursa Malaysia Securities Berhad ("BMSB").

For the current quarter ended 30 September 2023, the Group recorded a loss before tax of RM0.42 million, compared to a loss before tax of RM0.30 million and revenue of RM3.92 million reported in the preceding year's corresponding quarter. There is no revenue recognition in the current quarter as compared to revenue from the construction contract for the Centro @ JBCC project located at Johor Bahru for the preceding year's corresponding period. The loss before tax for the current quarter is primarily attributable to the group overhead cost for the current quarter.

For the current quarter ended 30 September 2023, the Group recorded a loss before tax of RM0.42 million, compared to a loss before tax of RM0.56 million on revenue of RM1.11 million reported in the preceding quarter. The lower loss before tax was mainly the result of the group overhead cost saving for the current quarter.

B4 Current year Prospects

For the second half of 2023, the Malaysian economy is expected to expand at a moderate pace. Slower external demand will continue to weigh on economic activity. Growth will be supported by domestic demand, underpinned by favourable labour market conditions, particularly in the domestic-oriented sectors. While the growth outlook is subject to some downside challenges stemming from weaker-than-expected global growth, although not discounting the possibility of upside potential.

The Group launches the Tanjung Kling, Melaka project during the month of November 2023. The Group is cautiously optimistic that construction activities will pick up with the launching of the project and will expect to perform better with the projects that are in the pipeline.

Going forward, the Group opines that with careful planning and execution, it will be better positioned strategically and operationally to improve its business performance, which would eventually contribute positively to the Group's earnings in the future.
