### A. NOTES TO INTERIM FINANCIAL REPORT

#### 15. PERFORMANCE REVIEW

The Group recorded a higher profit before taxation of RM716,000 in the current year to-date as compared to RM686,000 in the preceding year corresponding period. These were mainly due to higher interest income earned on deposits placed with financial institution and lower advertising and promotional expenses off set by the share of loss of the associated company in China.

### 16. VARIATIONS OF CURRENT QUARTER RESULTS AGAINST PRECEDING QUARTER

The results of the Group has improved significantly from a loss before taxation of RM5,000 in the preceding quarter to a profit before taxation of RM735,000 in the current quarter. This was mainly attributed to the higher sales in the domestic and international markets in the current quarter arising from the year end festive season as compared to the preceding quarter.

### 17. PROSPECTS OF THE GROUP

The Group anticipate macroeconomic conditions in Malaysia to remain challenging.

The Group will be vigilant and respond accordingly to the changing business dynamics and market environment with our constant focus in improving its performance.
