### A. NOTES TO INTERIM FINANCIAL REPORT

#### 1. BASIS OF PREPARATION

The interim financial report is unaudited and has been prepared in accordance with the Malaysian Financial Reporting Standards ('MFRSs'), International Financial Reporting Standards and the requirement of the Companies Act 2016 in Malaysia; Interim Financial Reporting and paragraph 9.22 of the Listing Requirements of Bursa Malaysia Securities Berhad.

The condensed interim financial statements should be read in conjunction with the audited financial statements of the Group for the financial year ended 31 December 2023. ### 15. PERFORMANCE REVIEW

The Group recorded a profit before taxation of RM 0.5 million in the current year as compared to a loss before taxation of RM 1.4 million in the preceding financial period. The improved result was mainly due to higher profit contributed by the increase in revenue as a result of higher demand of our biscuits from domestic & International market.

### 16. VARIATIONS OF CURRENT QUARTER RESULTS AGAINST PRECEDING QUARTER

The Group recorded a profit before taxation of RM 0.5 million in the current quarter as compared to loss before taxation of RM 1 million in the preceding quarter. The higher profit in the current quarter was mainly due to higher revenue from domestic market which contributed higher margin for the group.

#### 17. PROSPECTS OF THE GROUP

The Group anticipates macroeconomic conditions in Malaysia to remain challenging.

The Group will be vigilant and respond accordingly to the changing business dynamics and market environment with our constant focus in improving its performance.
