NOTES TO THE INTERIM FINANCIAL REPORT

1. Basis of preparation

These interim financial statements are unaudited and have been prepared in accordance with the requirements of MFRS 134 *Interim Financial Reporting* issued by the Malaysian Accounting Standards Board ("MASB") and paragraph 9.22 of the Bursa Malaysia Securities Berhad ("Bursa Securities") Main Market Listing Requirements ("MMLR"). The interim financial statements should be read in conjunction with the Group's audited financial statements for the financial year ended 30 June 2021 and the accompanying explanatory notes attached to these interim financial statements. The explanatory notes attached to the interim financial statements provide an explanation of events and transactions that are significant to an understanding of the changes in the financial position and performance of the Group since the year ended 30 June 2021.

The accounting policies and methods of computation adopted for the interim financial statements are consistent with those adopted for the audited financial statements for the financial year ended 30 June 2021.

Details of standards, amendments to published standards and interpretations to existing standards that are applicable to the Group with effect from 1 July 2021 or later are provided in note 2 to the audited financial statements of the Group for the financial year ended 30 June 2021. The adoption of the new standards and amendments/annual improvements to existing standards did not have any significant impact to the Group during the current quarter and financial period to date.

2. Audit Report of Preceding Audited Financial Statements

The preceding year's annual audited financial statements were not subject to any qualifications from the auditors.

3. Seasonal or Cyclical Factors

The operations are subject to the cyclical nature of the property and construction industry especially in the residential and hospitality segments.

4. Unusual items Affecting the Assets, Liabilities, Equity, Net Income or Cash Flows

There were no items affecting assets, liabilities, equity, net income or cash flows that were material and unusual because of their nature, size or incidence in the current quarter.

5. Changes in estimates

There were no material changes in estimates of amount reported in prior interim periods or in previous financial years which have a material effect in the current quarter.

6. Debt and equity securities

There were conversions of 100,000 Redeemable Convertible Preference Shares A (RCPS A) to 13,157 ordinary shares during the current quarter. As at the end of the current quarter the number of ordinary shares is 140,459,531. During the current quarter, the Company did not buy any shares as treasury shares and the number of treasury shares held remains at 109,872.

7. Dividends paid

On 9th June 2022, the Company paid single-tier second interim dividend of 0.2 sen for each RCPS A and RCPS B held on the entitlement date. The total cash paid amounted to RM667k.

14. Review of Performance

Q4 group turnover improved by 30% to RM32.9m from RM25.2m for the corresponding period a year ago. The manufacturing division's gross sales doubled to RM4.5m compared to RM2.2m a year earlier. Total number of stores shipped and stores sales from our major customer improved by 53% in the current quarter as compared to the corresponding period last year due to surge in store opening for stores that was previously delayed or postponed due to Covid-19 pandemic. Other sales for the current quarter was minimal at RM317k. The global supply-chain disruptions, labour shortage and the rising labour and freight cost had all resulted in margin compression and the lower gross margin is insufficient to absorb fixed factory operating expenses and overheads as well as additional expenses that was incurred due to factory relocation. Operating expenses for the current quarter was higher due mainly to higher staff cost as compared to the previous quarter. The division recorded an operating loss for the quarter of RM606k as compared to a profit of RM620k a year earlier. YTD turnover fell by 13% to RM14.2m from RM16.3m a year ago while YTD profit was at RM3.2m from RM1.3m for the same period a year ago.

Including inter-segment sales, the IFO division recorded turnover of RM4.7m in the current quarter. Except for the inter-segment sales in the current quarter, the division has not secured any material external projects as the division remains selective in submitting tenders for external projects in view of the current economic situation. Operating expenses was substantially lower compared to a year earlier due mainly to impairment of trade receivables of RM0.8m in the corresponding period last year. With the inter-segment sales, the division recorded operating profit of RM2.1m for the current quarter as compared to operating loss of RM2.1m a year earlier on margin recognized from the inter-segment sales as well as write back of provision for LAD claim of RM1m. YTD turnover including inter-segment sales improved to RM11.8m while YTD profit was at RM3.1m from a loss of RM3.2m a year ago.

The construction division's turnover improved by 23% to RM28.3m from RM23.1m for the same period a year ago. Gross margin was higher on account of higher billings. Operating expenses was higher in the current quarter as compared to last year due mainly to higher staff cost. The division registered the same operating profit of RM4.4m as compared to a year ago. At the end of the quarter the division has unbilled contacts of approximately RM110m carried forward. YTD turnover increased by 12% to RM111.7m compared to RM100m last year, meanwhile YTD PBT was down by 16% to RM10.9m from RM13m for the same period last year.

On consolidated basis, PBT increased by 2.5 times to RM5.2m from RM2m a year ago and PAT was correspondingly higher at RM4.5m compared to RM1.1m for the same period last year.

15. Comparison with Preceding Quarter

PBT for the current quarter decreased to RM5.2m from RM9.1m in the preceding quarter due mainly to one-off pre-tax gain on factory disposal of RM6.1m last quarter and higher margin from the construction and IFO division in the current quarter.

16. Current Year Prospects.

The manufacturing division of the Group has seen a significant reduction in export orders due to the slowdown in global retail sector as a result of the Covid-19 pandemic. The prospect for the manufacturing division going forward will hinge on the extent the Covid-19 pandemic has on its key customers' store expansion programme and the ability to secure other sales. The division has undertaken a cost optimisation exercise to reduce its operating overheads to mitigate the effect of the lower revenue while gross margin will hinge on the strength of the United States Dollar against the Ringgit and the production throughput.

A substantial portion of the interior fit-out (IFO) division's sales is derived from the hospitality industry that has been adversely affected by the pandemic. The division has not been able to secure any external projects in recent months and has been very selective in submitting tenders for external projects in view of the current economic situation. As such the decision has been made to scale down the operations and for the moment will concentrate on projects to be awarded by other divisions within the Group.

The construction division now has ongoing projects with a combined contract sum of RM289 million that will provide profit visibility and is expected to secure further related party contracts in the current year to ensure that it continues to make a significant contribution to the Group's result in financial year 2023. The prospect for the current year will hinge on the timely and uninterrupted execution of these projects as well as managing the effects on hike in construction cost.

With Malaysia transitioning to endemicity, the overall economic activity is projected to recover. However, the outlook is clouded by the current geopolitical tension, higher inflation and rising interest rate, higher input costs and disruption of supply chains. As a result of all these factors, the respective divisions could see some margin compression.

The Group actively explore for new businesses that can contributes positively to the Group continued growth. On 24 September 2021, Warrants RE Assets Sdn Bhd ("WREA"), has entered into a Memorandum of Understanding with SPIC Energy Malaysia Berhad, for both parties to enter into a business collaboration to acquire in part or in whole operating Feed-In Tariff, Net Metering and Large Scale Solar solar farm. On 2 November 2021, WREA has entered into a Memorandum of Understanding with Fabulous Sunview Sdn Bhd ("Sunview"), for business collaboration in the Renewable Energy Projects development in Malaysia. The Company also has a 6.72% interest in Sunview. The collaboration marked the Group's venture into the renewable energy segment and would help the Group to escalate the expansion of its footprint in the new segment.
