A1. Basis of preparation of interim financial report

The interim financial report is unaudited and has been prepared in accordance with the reporting requirements as set out in Financial Reporting Standards ('FRS') No. 134: Interim Financial Reporting and paragraph 9.22 of Bursa Malaysia Securities Berhad ("Bursa Securities") Listing Requirements and should be read in conjunction with the Company's audited financial statements for the year ended 31 December 2009.

The total comprehensive income for the period is presented as a one-line item in the statement of changes in equity.

This Standard does not have any impact on the financial position and results of the Group.

ii) FRS 139 Financial Instruments: Recognition and Measurement

Prior to the adoption of FRS 139, financial derivatives are recognised on their settlement dates. Outstanding derivatives at the balance sheet date were not recognised. With the adoption of FRS 139, all financial assets and financial liabilities, including derivatives, are recognised at contract dates when, and only when, the Company or any subsidiary becomes a party to the contractual provisions of the instruments.

The measurement bases applied to the financial assets and financial liabilities in the prior financial year were changed to conform to the measurement standards of FRS 139 in the current quarter. At initial recognition, all financial assets and financial liabilities are measured at fair value plus in the case of financial instruments not at fair value through profit or loss, transaction costs directly attributable to the acquisition or issuance of the instruments. PART B: ADDITIONAL INFORMATION REQUIRED BY THE LISTING REQUIREMENTS OF BURSA MALAYSIA

B1. Review of performance

The Group registered a lower pretax loss of RM4.5 million for the current quarter vis-a-vis pretax loss of RM5.1 million in the preceding year corresponding third quarter, with lower revenue at RM17.3 million in the current quarter compared to RM18.6 million in the third quarter last year.

The Group's performance, mainly driven by the disposable foodwares manufacturing business, continues to operate in a difficult business environment with adverse effects of the prevalent volatile prices of petrochemical resin materials, increase in energy/fuel cost and interest rate as well as intensified competition. Notwithstanding sales have decreased to RM13.7 million (9% decline) compared to third quarter last year, the ongoing product mix and cost rationalization have positive effects in countering the higher fuel/energy costs and finance cost for the manufacturing facility – resulting in a lower pretax loss of RM3.4 million (by 28%) vis-à-vis RM4.7 million pretax loss in the preceding year corresponding third quarter. Meanwhile, the kaolin mining incurred pretax loss of RM0.2 million compared to pretax profit of RM0.05 million in the preceding year corresponding third quarter as margins were affected by the drop in production volume, higher crude clay expenses and rising operational costs arising due to hikes in fuel and energy costs.

B2. Variation of results against preceding quarter

The Group registered a lower revenue of RM17.3 million for the current quarter compared to the preceding quarter's revenue of RM17.7 million, with a lower Group's pretax loss at RM4.5 million vis-à-vis pretax loss of RM5.8 million in the preceding quarter. The disposal foodwares business incurred a lower pretax loss at RM3.7 million in the current quarter compared to a pretax loss of RM4.3 million in the preceding quarter benefiting further from cost rationalization exercises implemented to mitigate escalation in petrochemical resin materials costs and other operating costs. The kaolin mining incurred pretax loss of RM0.2 million compared to pretax loss of RM0.4 million in the preceding quarter as higher turnover was achieved in current quarter.

B3. Current year prospects

The remaining period of the year will continue to be challenging with the prevalent volatile raw materials prices and overheads (particularly fuel and energy costs) together with higher interest cost. Nevertheless, the Group will continue to focus on costs rationalization and management, besides operating efficiency strategies to enhance its competitive edge. The disposable foodwares business is expected to further extend its JASA Eco products range and reach, besides increasing export market sales. The kaolin mining is anticipated to turnaround, contributing profit by year end. The Group will persevere in striving to achieve a turnaround.
