NOTES TO THE INTERIM FINANCIAL REPORT FOR THE FINANCIAL QUARTER ENDED 31 MARCH 2014

A. FRS134 – Interim Financial Reporting

A1. **Basis Preparation**

This interim financial report is unaudited and is prepared in accordance with the Malaysian Financial Reporting Standards ("MFRS") No 134: Interim Financial Reporting and paragraph 9.22 of the Listing Requirements of Bursa Malaysia Securities Berhad and should be read together with the Group's Audited Financial Statement for the year ended 30 June 2013.

The interim financial report should be read in conjunction with the audited financial statements of the Group for the year ended 30 June 2013. These explanatory notes, attached to the condensed consolidated interim financial statements, provide an explanation of the events and transactions that are significant to the understanding of the changes in the financial position and performance of the Group since the financial year ended 30 June 2013. The audited financial statements of the Group as at and for the year ended 30 June 2013 were prepared under Malaysian Financial Reporting Standards (MFRSs).

A2. Significant Accounting policies

As at to-date, the Company is holding 106,000 EG shares purchased which are all held as Treasury Shares. The total consideration paid for the repurchase including transaction costs was RM28,777.90.

The Group has recorded revenue of RM250.6 million for the current quarter and RM760.0 million for year to date. The revenue has increased by RM42.0 million as compared to the last year corresponding quarter and increased by RM152.9 million for year to date respectively. The Group recorded a pre-tax profit of RM1.964 million for the current quarter as compared to RM2.483 million for the same quarter last year.

The increase in revenue for the current quarter under review was due to the increase in sales recorded by the EMS division at Malaysia plant as well as Thailand plant. The decrease in pre-tax profit was mainly due to the higher depreciation and finance costs incurred in respect of the new investment in machineries.

B2. Material Changes in the Profit Before Taxation for the Quarter Reported On as Compared with the Immediate Preceding Quarter

For the quarter under review, the Group recorded a pre-tax profit of RM1.964 million (sales: RM250.6 million) as compared to the immediate preceding quarter pre-tax profit of RM0.836 million (sales: RM262.0 million). The increase in profit despite lower sales was mainly due to the favorable exchange rate for USD/MYR.

The Group will strive to ensure that it achieve satisfactory result by taking prudent measures and improving operational efficiency.
