16 Review of Performance

Comparison with the corresponding quarter in the previous financial year

For the current quarter under review, the Group's total revenue decreased by 15.22% to RM70.67 million from RM83.36 million in the previous corresponding quarter.

Revenue for the retail segment constituted RM43.44 million in the current quarter as compared to RM56.07 million in the previous corresponding quarter, a decrease of 22.53%. This is primarily due to the late commencement of the traditional end of season sales for a particular international label. In addition, this quarter faced sluggish sales as a result of the uncertainties in the run up to the recently held general election coupled with the resultant discontinuation of our association with Calvin Klein Jeans. As such, profit before tax for the segment registered a decline of 81.87% to RM1.01 million from RM5.57 million.

Revenue for the garment manufacturing segment totalled RM27.73 million, a decrease of 13.30% from RM31.99 million in the previous corresponding quarter. Of this, inter-company sales amounted to RM0.50 million in this quarter as compared to RM4.70 million in the previous corresponding quarter. The garment manufacturing segment registered a modest profit of RM0.01 million for the current quarter as compared to a loss of RM0.53 million for the previous year's corresponding quarter, mainly due to improved cost and operational efficiencies.

17 Comparison with Immediate Preceding Quarter

The Group registered a 12.78% decrease in total revenue to RM70.67 million in the current quarter as compared to RM81.03 million achieved in the immediate preceding quarter ended 31 March 2013.

The retail segment recorded a decrease of 13.11% to RM43.44 million in the current quarter as compared to RM49.99 million in the preceding quarter.

17 Comparison with Immediate Preceding Quarter (Cont'd)

As for the garment manufacturing segment, it recorded a decrease of 24.39% to RM27.73 million in the current quarter as compared to RM36.68 million in the immediate preceding quarter. Of this, inter-company sales amounted to RM0.50 million from RM5.65 million previously.

The Group recorded an increase of 205.76% in profit before tax to RM1.01 million in the current quarter from RM0.33 million in the immediate preceding quarter.

Profit before tax for the retail segment decreased by 54.20% to RM1.01 million in the current quarter from RM2.20 million in the immediate preceding quarter. The garment manufacturing sector recorded a modest profit of RM0.1 million in the current quarter as compared to a loss of RM1.76 million in the immediate preceding quarter.

The Group is continuing with its positive outlook, whilst being mindful and vigilant over the instability in the global economy.
