18. Operating losses have been reduced due to severe cost cutting measures despite lower turnover. The building at Northam Road in Penang has recommenced construction under a new financial package and is due for completion at the end of the year 2000. The company obtained a Section 176 Restraining order on its creditors on 24th November 1999. Negotiations with a "White Knight" are truly well underway and it is expected that a formal Sales & Purchase agreement will be concluded by the end of the year to complete a composite restructuring of the Group together with its lenders and creditors.
19. The Plastics manufacturing activities of the group that are currently manufactured under Watford Technologies Sdn Bhd (formerly known as MYH Construction Sdn Bhd) are operational on a limited scaled down basis. We do not see positive growth in the last quarter of this year due to
- (i) increased prices for Raw Materials by over 20%.
 - (ii) Cyclical downturn in the last quarter of the year.
