#### 1. Review of performance

The Group recorded revenue of RM305.4 million for the 1<sup>st</sup> quarter period to 31 March 2024 as compared with RM242.9 million recorded in the preceding year corresponding quarter period.

Paper milling division turnover was RM3.2 million lower than previous year corresponding quarter period, paper converting division turnover was higher by RM12.7 million compared with the previous year quarter.

Building materials division recorded a higher turnover of RM43.2 million compared with the preceding year quarter period and other operations divisions reported higher turnover compared with the preceding year quarter of RM14.7 million. The property development current quarter is Nil.

For year 2024, the 1<sup>st</sup> quarter revenue had registered growth in most segments except for paper milling division due to Malaysian economy having continued to registered growth.

## 2. Variation of results against immediate preceding quarter

The Group recorded a profit before taxation and interest of RM7.2 million for the 1<sup>st</sup> quarter to 31 March 2024 as compared to a profit of RM5.7 million recorded in the preceding 4<sup>th</sup> quarter 2023.
