NOTES TO THE INTERIM FINANCIAL STATEMENTS

1. Basis of preparation

The interim financial statements are unaudited and have been prepared in accordance with Financial Reporting Standards ("FRS") 134: "Interim Financial Reporting" issued by the Malaysian Accounting Standards Board and paragraph 9.22 of the Bursa Malaysia Securities Berhad Main Market Listing Requirements. The interim financial statements should be read in conjunction with the audited financial statements for the year ended 31 July 2011. These explanatory notes attached to the interim financial statements provide an explanation of events and transactions that are significant to an understanding of the changes in the financial position and performance of the Group since the year ended 31 July 2011.

2. Significant accounting policies

The significant accounting policies and methods of computation adopted by the Group in this interim financial statements are consistent with those of the audited financial statements for the year ended 31 July 2011, except for the adoption of new/revised Financial Reporting Standards (FRSs), Amendments to FRSs and IC Interpretations effective for financial year beginning 1 August 2011.

The application of the new/revised FRSs, Amendments to FRSs and IC Interpretations did not result in any material financial impact to the Group, except for changes in disclosures.

Amendments to FRS 7: Improving Disclosure about Financial Instruments

The *Improving Disclosures about Financial Instruments* reinforces existing principles for disclosures about liquidity risk. Also, the amendments require enhanced disclosures about fair value measurements in which a three-level fair value hierarchy is introduced.

The Group is required to classify fair value measurements using this hierarchy which is based on the inputs used in determining the measurement.

3. Audit report of preceding annual financial statements

The audit report of the Group's most recent audited financial statements for the year ended 31 July 2011 was not qualified.

4. Seasonality or cyclicality of operations

There was no material seasonal or cyclical fluctuation in the operations of the Group.

The Directors are of the opinion that the above transactions were in the normal course of business and at terms mutually agreed between the companies.

15. Review of Performance of the Group

The Group's revenue for the first quarter ended 31 October 2011 decreased by RM13.2 million or 21%, from preceding year's corresponding period of RM63.6 million to RM50.4 million, as a result of lower demand for burn-in, testing and electronic manufacturing services.

Other items of income increased by RM4.1 million, compared to preceding year's corresponding period. The increase was largely due to (i) an exchange gain of RM1.5 million, arising mainly from appreciation of US Dollars against Ringgit on US Dollars denominated receivables, and (ii) RM2.7 million grant, an incentive given by the China government for technology upgrade.

Operating expenses decreased by RM3.9 million or 7%, from preceding year's corresponding period of RM56.6 million to RM52.7 million. This was primarily attributed to lower labour, material and overhead costs due to lower sales, being offset by higher depreciation as a result of expanded capacity.

In effect, the Group's profit before tax reduced by RM5.2 million or 61%, from RM8.6 million in the preceding year's corresponding quarter, to RM3.4 million for the quarter under review.

16. Material change in the profit before taxation compared to the results of the preceding quarter

The Group's profit before tax for the first quarter ended 31 October 2011 were lower by RM0.4 million, from RM3.8 million in the preceding quarter ended 31 July 2011 to RM3.4 million for the first quarter ended 31 October 2011, mainly due to lower sales.

17. Prospects

The global semiconductor industry is expected to register a year-on-year negative revenue growth of 0.1% to USD229 billion in 2011.

In light of a weak US economy recovery and the uncertainty of the Eurozone debt bailout plans, the Group's business momentum may slow down further.

The Group will continue its efforts on stringent cost controls and productivity improvements to weather through this challenging and volatile business environment.
