NOTES TO THE INTERIM FINANCIAL STATEMENTS

1. Basis of preparation

The interim financial statements are unaudited and have been prepared in accordance with Financial Reporting Standards ("FRS") 134: "Interim Financial Reporting" issued by the Malaysian Accounting Standards Board and paragraph 9.22 of the Bursa Malaysia Securities Berhad's Main Market Listing Requirements. The interim financial statements should be read in conjunction with the audited financial statements for the year ended 31 July 2011. These explanatory notes attached to the interim financial statements provide an explanation of events and transactions that are significant to an understanding of the changes in the financial position and performance of the Group since the year ended 31 July 2011.

2. Significant accounting policies

The significant accounting policies and methods of computation adopted by the Group in the interim financial statements are consistent with those of the audited financial statements for the year ended 31 July 2011, except for the adoption of new/revised Financial Reporting Standards (FRSs), Amendments to FRSs and IC Interpretations effective for financial year beginning 1 August 2011.

The application of the new/revised FRSs, Amendments to FRSs and IC Interpretations did not result in any material financial impact to the Group, except for changes in disclosures.

Amendments to FRS 7: Improving Disclosure about Financial Instruments

The *Improving Disclosures about Financial Instruments* reinforces existing principles for disclosures about liquidity risk. Also, the amendments require enhanced disclosures about fair value measurements in which a three-level fair value hierarchy is introduced.

The Group is required to classify fair value measurements using this hierarchy which is based on the inputs used in determining the measurement.

3. Audit report of preceding annual financial statements

The audit report of the Group's most recent audited financial statements for the year ended 31 July 2011 was not qualified.

4. Seasonality or cyclicality of operations

There was no material seasonal or cyclical fluctuation in the operations of the Group.

5. Nature and amount of items affecting assets, liabilities, equity, net income, or cash flows that are unusual because of their nature, size, or incidence

There were no unusual items affecting assets, liabilities, equity, net income, or cash flows during the reporting period.

6. Changes in estimates of amounts reported in prior interim periods of the current financial year or in prior financial years

There were no changes in estimates of amounts reported in prior financial years.

7. Issues, repurchases, and repayments of debt and equity securities

There were no issues, repurchases and repayments of debt and equity securities for the current financial year-to-date.

8. Dividends paid

A first and final tax exempt dividend of 3 sen per ordinary share, amounting to RM1,290,000, in respect of the previous financial year ended 31 July 2011, was paid on 20 January 2012.

16. Detailed analysis of Group performance

Analysis of the performance for the current quarter

The Group's operating segment comprising revenue from burn-in, testing and electronic manufacturing services decreased by RM5.4 million, from RM63.7 million in the preceding year's corresponding quarter to RM58.3 million for the current financial quarter ended 31 January 2012, because of lower demand.

Other income increased from RM0.8 million to RM2.4 million, as the operating segment registered: (i) higher net exchange gain by RM0.6 million, arising from appreciation of US Dollars against Ringgit on US Dollars denominated receivables, and (ii) reversal of sundry payables of RM0.7 million, whilst (iii) investment holding segment reported higher fair value gain on investment securities by RM0.4 million, compared to preceding year's corresponding quarter.

Raw materials and consumables used and changes in work-in-progress were lower by RM3.2 million or 19%, from RM16.8 million to RM13.6 million in the current reporting quarter, mainly because of lower electronic manufacturing services sales.

Similarly, depreciation of property, plant and equipment was higher by RM1.2 million or 9%, as a result of expanded capacity in burn-in and testing services.

In effect, the Group's profit before tax decreased by RM1.5 million or 26%, from RM5.9 million in the preceding year's corresponding quarter to RM4.4 million in the current reporting quarter under review.

Analysis of the performance for the current financial year-to-date

The Group's operating segment reported lower revenue by RM18.6 million, from RM127.2 million in the preceding year's corresponding period to RM108.6 million for the current financial period ended 31 January 2012. This was attributed to lower demand.

Other income increased from RM1.7 million to RM7.0 million in the current period under review. This was primarily due to (i) the operating segment reporting a net exchange gain of RM2.5 million (as opposed to a net exchange loss of RM0.4 million in the corresponding period recognized in "Other expenses") arising from appreciation of US Dollars against Ringgit on US Dollars denominated receivables, (ii) RM2.7 million incentive grant given by the China government for technology upgrade, (iii) reversal of sundry payables of RM1.4 million, partially offset by lower fair value gain on investment securities of RM1.5 million recorded by the investment holding segment, following a marginal slide in the stock market index for the current financial period ended 31 January 2012.

Raw materials and consumables used and Changes in work-in-progress decreased by RM6.9 million or 22%, from RM31.0 million to RM24.1 million in the current reporting period, because of lower electronic manufacturing services sales.

Depreciation of property, plant and equipment was higher by RM3.9 million or 16%, as a result of expanded capacity in burn-in and testing services.

Other expenses were lower by RM2.4 million from the preceding year's corresponding period. This was mainly due to lower repair and maintenance as a result of lower machine usage.

Analysis of the performance for the current financial year-to-date (cont'd)

In effect, the Group's profit before tax reduced by RM6.8 million or 46%, from RM14.5 million in the preceding year's corresponding period to RM7.8 million in the current reporting period under review.

17. Material change in the profit before taxation compared to the results of the preceding quarter

The Group achieved profit before tax of RM4.4 million for the current quarter ended 31 January 2012, compared to RM3.4 million in the preceding quarter ended 31 October 2011. This represented an increase of RM1.0 million or 29%.

The improvement in profit before tax was the result of:

- i) improved demand for its testing and electronic manufacturing services;
- ii) fair value gain on investment securities held for trading; offset by
- iii) higher labour and material consumption on the back of improved sales;
- iv) lower net exchange gain arising from lower net US Dollars denominated receivables;
- v) absence of one-off gain of RM2.7 million incentive grant in the preceding quarter, given by the China government for technology upgrade.

18. Prospects

The global semiconductor industry has projected a year-on-year revenue growth of 2.2% to USD309 billion in 2012. This modest projection was made in response to the softening global demand arising from continued uncertainties over the future of the Eurozone, alongside the inventory correction, manufacturing oversupply and natural disasters.

With uncertainty clouding the outlook of the world's economic recovery, the Group continues to focus on cost management and productivity improvements.

19. Profit forecast / profit guarantee

The Group was not subjected to any profit guarantee.
