(A) NOTES TO THE INTERIM FINANCIAL REPORT FOR THE QUARTER ENDED 31 MARCH 2012

1. BASIS OF PREPARATION

The interim financial statements are unaudited and have been prepared in accordance with the requirements of Financial Reporting Standard ("FRS") 134 Interim Financial Reporting and paragraph 9.22 of the Listing Requirements of Bursa Malaysia Securities Berhad.

The interim financial statements have been prepared under the historical cost convention except for investment properties that are stated at fair value.

The interim financial statements should be read in conjunction with the audited financial statements for the year ended 30th June 2011. The explanatory notes attached to the interim financial statements provide an explanation of events and transactions that are significant to an understanding of the changes in the financial position and performance of the Group since the financial year ended 30th June 2011.

The financial statements are presented in Ringgit Malaysia (RM) and all values are rounded to the nearest ringgit (RM) except when otherwise indicated.

2. CHANGES IN ACCOUNTING POLICIES

The significant accounting policies adopted are consistent with those of the audited financial statements for the year ended 30th June 2011 except for the adoption of:

The Group is principally involved in the manufacture, wholesale and retail of garments and related accessories. The demand for the Group's products is generally dependent on the Malaysian economy, consumer confidence and is seasonal with demand peaking at the festive seasons at the end and beginning of the year.

There were no unusual items affecting assets, liabilities, equity, net income, or cash flows for the financial period under review.

1. REVIEW OF PERFORMANCE

For the current quarter under review, the Group's revenue decreased by 7.10% or RM1.37 million to RM17.92 million from RM19.29 million reported in the previous year corresponding quarter. During the same period, the Group recorded a loss before tax of RM0.46 million as compared to loss before taxation of RM0.13 million in the previous year corresponding quarter.

The decrease in sales by RM1.37 million from sales of children's apparels is due to stiff competition among children apparels and the influx of additional brands into the market. The Group achieved a higher loss before tax despite an increase in gross profi margin by 2% due to an increase in operating expenses and finance cost.

For the cumulative 9 months period ended, the Group's revenue is RM85.44 million, a decline of RM2.12 million or 2.42% as compared to RM87.56 million recorded in the corresponding period. In addition to stiffer competition, the decline is also due to discontinuation of certain outright sales and wholesale division .

2. COMPARISON WITH PRECEDING QUARTER'S REPORT

The higher revenue achieved in the previous quarter under review was mainly due to higher sales recorded during the nationwide mega sales, year end school holidays and Christmas festive seasons. The lower sales achieved in the third quarter as a result of Chinese New Year falling in third week of January, thus February and March remain quiet months with less sales activities.

The Group recorded a loss before taxation of RM0.46 million during the current quarter under review, a decline of 169.70% or RM1.12 million as compared to a profit before taxation of RM0.66 million registered in the preceding quarter. This was caused by the substantial drop in revenue although operating expenses remained the same.

3. COMMENTARY ON PROSPECTS

The Malaysian economy expanded at 5.1 % for 2011, driven mainly by the domestic consumption and recovery in the manufacturing sector. Nevertheless, the present competitive trend of the apparels industry is expected to continue with additional competitors coming into the retail industry. The Group will continue to review its marketing and sales strategies and aggressively pursue more sales activities.

The Group will continue to strive to improve its brand presence and product mix in order to achieve better sales and better gross margins. With the implementation of minimum wage policy as announced by the government, cost of operations will continue to escalate and the Group will strive to improve its cost efficiencies in order to improve its performance. The Group will adopt a cautious approach in expanding its business and explore new opportunities.
