The financial report is unaudited and has been prepared in accordance with Malaysian Financial Reporting Standard (“MFRS”), International Financial Reporting Standards (“IFRSs”) and paragraph 9.22 and Appendix 9B of the Bursa Malaysia Securities Berhad (“Bursa Malaysia”) Listing Requirements.

The financial statements should be read in conjunction with the audited financial statements of the Group for the financial year ended 31 December 2019. The explanatory notes attached to the financial statements provide an explanation of events and transactions that are significant to an understanding of the changes in the financial position and performance of the Group since the year ended 31 December 2019.

Note 2 Summary of Significant Accounting Policies

No material event has occurred subsequent to the current quarter that have not been reflected in the financial statements for the said quarter as at the date of issue of this quarterly report.

Note 12 Changes in Composition of the Group

On 31 December 2020, Seni Jaya Sdn. Bhd. ("SJSB"), a wholly owned subsidiary of the Group acquired an additional 70% of the ordinary shares in Seni Jaya OOH Sdn. Bhd. ("SJOOH") and Seni Jaya Media Utama Sdn. Bhd. ("SJMU") for total consideration of RM700,001. Consequently, SJOOH and SJMU became wholly owned subsidiaries of the Group.

Note 13 Contingent Liabilities

Contingent liabilities of the Company as at 31 December 2020 are in respect of a corporate guarantee with the guaranteed sum of RM 5,000,000.00 issued by the Company in favour of RHB bank as security for banking facilities granted by RHB bank to a subsidiary. The said banking facilities granted by RHB bank comprised of:

- a) Overdraft facility of RM5,000,000.00; and
- b) Bank Guarantee facility of RM2,800,000.00

There was no capital expenditure incurred for the Group for current financial period.

Note 16 Review of Performance For The Current Quarter VS. Corresponding Quarter of the Preceding Financial Year

For the quarter under review, the Group recorded revenue of RM1.69 million and a loss before tax of RM3.17 million respectively, as compared with the revenue of RM3.39 million and a profit before tax of RM0.02 million in the corresponding quarter of preceding financial year. The decrease in revenue was mainly attributable to the Covid-19 outbreak with the resulting market challenges. Cost of sales and other operating expenses in the current quarter has reduced significantly as most major refurbishments has been carried out in preceding year and lesser maintenance required which is in line with the drop of revenue. However, the recognition of fair value loss on investment on financial assets, amortized non-current portion of amount due from associate and write-offs PPE had increased the operating expenses as compared to preceding year.

Note 17 Review of Performance for the Current Year VS. Preceding Year

In the year under review, the Group recorded lower revenue of RM8.82 million, as compared to the preceding year of RM14.56 million. Meanwhile, the loss before tax in the current year under review is RM5.21 million, as opposed to loss before tax of RM0.10 million in the preceding year. The loss position in the current year was mainly contributed by the drop of revenue which is in line with the reduction of operating expenses as compared to preceding year. However, the recognition of fair value loss on investment on financial assets, amortized non-current portion of amount due from associate and write-offs PPE had increased the operating expenses as compared to preceding year.

Note 18 Coming Year's Prospects

Barring unforeseen circumstances such as the Covid-19 pandemic, the Board is of the opinion that the Group's performance will remain positive in the next financial year of 2021. The Board of Directors and senior management team are implementing strategies that will bring positive financial impact by introducing digital billboards, as well as upgrading existing sites at prime locations to increase yield. Management team is committed to support the Group's business activities at all times and to further strengthen the market position of the Group.
