B1 Review of Performance

The Group recorded total revenue of RM140.376 million for the current quarter under review compared to RM99.293 million in the corresponding preceding quarter. This represents an increase of 41% due to the ongoing construction of Ideal Residency, Havana Beach Residences and Ideal Venice. The Group's latest project, Lucerne Residences has commenced construction in the first quarter. 1st Avenue Mall recorded total rental income of RM2.981 million for the current quarter. The Group's venture into selling and development of Penang Technology Park @ Bertam industrial plots has also contributed to the revenue for the current quarter.

The group achieved a profit after tax of RM15.736 million attributable to the owners as compared to profit after tax of RM6.083 million in the corresponding preceding quarter. The increase in profit is mainly from the steady construction of the Group's current projects, selling and development of Penang Technology Park @ Bertam industrial plots.

For the current quarter under review, revenue increased by 29% from RM108.755 million in the immediate preceding quarter to RM140.376 million. Profit before tax of RM25.139 million was recorded for the current quarter.

Projects that are currently under way and in active progress includes Ideal Residency, an affordable homes project strategically located in the heart of Penang, Havana Beach Residences, a beach-inspired affordable home development in Bayan Lepas, the fastest growing district in Penang, Ideal Venice, the second phase of PR1MA affordable homes project located next to Ideal Residency and finally Lucerne Residences, a resort style residential project with European charm that has started construction in the previous quarter. Sales and development of Penang Technology Park @ Bertam industrial plots has started in the current quarter and has received positive response from investors of all fields.

Besides, the Group has now embarked on the selling of industrial lands with the announcement that the two subsidiaries, Lestari Duta Sdn Bhd and Mujur Sinarjaya Sdn Bhd (both of which are 70% owned) to purchase 17 parcels of freehold land for subdivision and sale.
