1. Review of Performance

For the financial quarter ended 30 September 2010, the Group recorded a turnover and profit before taxation of RM 13,380,000 and RM 2,733,000 respectively.

The Group recorded a higher turnover for the current financial quarter compared to RM 5,770,000 posted in the corresponding quarter in 2009.

For the period under review, the Group recorded a net profit after taxation of RM 2,347,000 as compared to the profit after taxation of RM 581,000 recorded in the same financial quarter last year.

2. Review of Current Quarter Profitability Against Preceding Quarter

The Group registered a turnover of RM13,380,000 in the current financial quarter as compared to RM 18,600,000 achieved in the immediate preceding quarter.
