ADDITIONAL EXPLANATORY NOTES OF THE LISTING REQUIREMENTS OF THE BMSB

1. Review of Performance

For the financial quarter ended 30 September 2011, the Group recorded a turnover and profit before taxation of RM15.705 million and RM3.098 million respectively.

The Group recorded a higher turnover for the current financial quarter compared to RM13.380 million posted in the preceding year corresponding quarter.

For the period under review, the Group recorded a net profit after taxation of RM1.718 million as compared to the net profit after taxation of RM2.347 million recorded in the same financial quarter last year.

2. Review of Current Quarter Profitability against Preceding Quarter

The Group registered a turnover of RM 15.705 million in the current financial quarter as compared to RM17.392 million achieved in the immediate preceding quarter. The Group recorded a profit before taxation of RM3.098 million as compared to a profit before taxation of RM 5.503 million recorded in the immediate preceding quarter.

3. Prospects

The robust growth of the property market over the years seems to have slowed down somewhat recently in tandem with the economic uncertainties experienced by USA and European Union which have a negative impact on the Malaysian economy, particularly on our export sector. Operating within these uncertain economic environments, the Directors now expect the profit of the Group for the current financial year to be lower than that achieved in the last financial year.
